A copy of the contract, which describes the work in more detail, is attached hereto as Exhibit 3.

The labor and materials were provided with the knowledge and consent of Owner. The original contract price was \$3,495.00.

- On March 4, 2009, Claimant completed all work required by the Contract and furnished labor and materials required by the Contract to the value of \$3,495.00.
- As of the date hereof, there is due, unpaid, and owing to Claimant, after all payments and credits, the principal sum of \$3,495.00 which principal amount bears interest at the statutory rate of 10 percent per annum. Claimant claims a lien on the Premises, the land and improvements, and on any monies or other consideration due or ner,
