Wood, Inc., entered into a written contract with Claimant on June 3, 2008, for Claimant to provide improvements as **concrete contractor**, for the new construction of a multi-unit building upon the premises. The contract was for Claimant to provide, concrete related labor and materials, including, inter alia, footings and walls, framing and concrete work for step wall, basement slab, removal and replacement of sidewalk, in the amount of \$25,392.

Pursuant to the contract, Claimant provided its labor and materials upon the premises, and substantially completed its contract to the amount of \$20,082, which included provision of the following: footings and walls, framing and concrete work for step wall, basement slab, removal and replacement of sidewalk. Claimant last provided labor and materials on March 9, 2009. Claimant ce sed work due to non-payment of labor and materials rendered (such non-payment was violation of the contract), despite numerous requests for same.

Claimant asserts to at it is an original contractor. In the alternative, on or before June 3, 2008, Contractor had a contract with Owner 1021 N. Wood, Inc., for Contractor's provision of construction labor and praterials for new construction upon the premises, and on June 3, 2008, Contractor entered into the above contract with Claimant; Contractor contracted with Claimant with the knowledge and approval and direction of the Owners. Before Claimant completed its provision of labor and materia's at and for the premises, RU Development, Inc., with Owners and with Claimant, for Claimant's continuing provision of labor and materials at and for the premises.

Owners (or Contractor, in the alternative) is/are entitled to credits as follows: \$0.
