

 Love, Truth, Peace, Freedom and Justice deposes:


We are Free Moorish American Nationals of Ai Moroc (America) North, Central,





I, Sheikh Dauwd Amun Al (ex rel: Dauwd Amun El) hereby **REVOKE, CANCEL** and render **NULL & VOID, nunc pro tunc**, both currently and retroactively to the time of signing any and **ALL** such contracts.



## RIGHT TO TRAVEL AFFIDAVIT: Waiver of Drivers License, Vehicle Registration and Insurance

For corporate, federal, State, city, and municipal jurisdictions

**This Affidavit is submitted upon request or demand for a driver's license, vehicle registration or proof of insurance as part of The Official Record of ANY ensuing action(s) and therefore MUST be introduced as evidence in said action(s).**

I, Sheikh Dauwd Amun Al do hereby **Affirm** that I AM a de jure **Moorish American National/Moor**, an indigenous and aboriginal inhabitant of this Land of Al Moroc/Northwest Amexem/ America. I am **NOT** a member or citizen of, franchisee of, or resident (agent) of the corporate State of New Jersey, or the federal United States.

I, Sheikh Dauwd Amun Al do **NOT** under **ANY** circumstances utilize the public highways for commercial purposes. I am **NOT** a 14th Amendment legal "person" engaged in interstate commerce, nor do I derive income from the travel or transport of goods. I am **NOT** a "driver" nor am I an "operator" of a "motor vehicle". The "driver's license" is for vehicles involved in **commerce only**. My private, self-propelled conveyance/carriage is not involved in commerce; therefore, it is **NOT** a "motor vehicle". The corporate State of New Jersey Department of Motor Vehicle code does not disclose the true purpose and intent of the statutes, though a "motor vehicle" is adequately and clearly defined in the United States Code (USC).

***"Motor Vehicle means every description of carriage or other conveyance propelled or drawn by mechanical power and used for commercial purposes"---18 USC 31***

***"The privilege of using the streets and highways by the operation thereon of motor carriers for hire can be acquired only by permission or license from the State or its political subdivision."*---Black's Law Dictionary, 5th ed, page 830**

*The right of the citizen to travel upon the public highways and to transport his property thereon either by carriage or automobile, is not a mere privilege which a city (or State) may prohibit or permit at will but a common right which he has under the right of life, liberty and the pursuit of happiness.” -----Thompson v. *“Even the legislature has no power to deny to a citizen the right to travel upon the highway and transport his property in the ordinary course of his business or pleasure, though this right may be regulated in accordance with the public interest and convenience.” [“Regulated” means traffic safety enforcement, stop lights, signs, etc.] -----Chicago Motor Coach v. Chicago 169 NE 22*

I, Sheikh Dauwd Amun Al do hereby certify, and Affirm that I am a **Moorish American National/Moor**, and a de jure citizen of The United States of America Republic (1787/1791) and a sovereign state citizen of the New Jerseyl state Republic in which I am domiciled. I, Sheikh Dauwd Amun Al am a “*natural born citizen*” (see U.S. Constitution, Article 2, Section 1, Clause 4). I am **NOT** subject to the statutory, colorable law jurisdiction of the federal *United States* in the corporate monopoly of the federal, State, local and municipal governments. I am **NOT** voluntarily or intentionally waiving, **ANY** of my unalienable rights, and have utterly **NO** intention of doing so in the future.

Therefore I, Sheikh Dauwd Amun Al in good faith apply for nor accept a driver’s license, as I would be committing **PURJURY!!** I would have to swear under oath that I am a member of, citizen of, franchisee of, or resident (agent) {fiduciary, surety for} the corporate State of New Jerseyl, when the already established facts by this affidavit serves as evidence that I am **NOT** a member or citizen of, franchisee of, or resident (agent) of the corporate State of New Jerseyl or the federal United States..

I have secured my **UNALIENABLE, FUNDAMENTAL, UNRESTRICTED, and UNREGULATED RIGHT TO TRAVEL** upon all the public walkways and the highways, and to transport my personal and allodial property, duly conveyed, unhindered by **ANY** private, corporate or statutory law(s), or department of Motor Vehicles (DMV) regulation(s) or so-called requirement(s).

ANY action involving a citation or ticket issued, confiscation, impoundment, or search and seizure of my private property by a police officer(s) or ANY other public servant(s) or employee(s) which carries a fine or jail time is a penalty or sanction, therefore it is a direct violation of The Organic Constitution of the United States of America Republic, converting a right into a crime. ## Prosecution


The abuse of the legal system through the misuse of process, misconduct of office, and/or malfeasance-doing is an act that is constitutionally wrongs in and of it self.



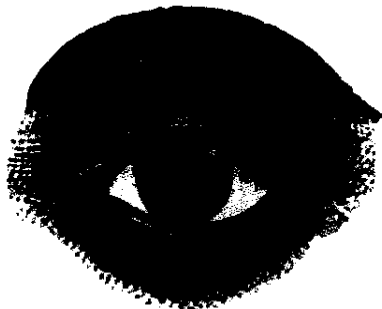
