The Mortgagor agrees that any legal action or proceeding with respect to any of its obligations under this Amendment may be brought by the Mortgagee in any state or federal court located in the State of Illinois, as the Mortgage in its sole discretion may elect. By the execution and delivery of this Amendment, the Mortgagor submits to and accepts, for uself and in respect of its property, generally and unconditionally, the non-exclusive jurisdiction of those courts. The Mortgag or waives any claim that the State of Illinois is not a convenient forum or the proper venue for any such suit, action or proceeding.
