#### **AGREEMENT**



AGREEMENT dated this 27th day of August, 1998, by and between the VILLAGE OF FLOSSMOOR, an Illinois Municipal Corporation, hereinafter referred to as "FLOSSMOOR", and BAYTHORNE CONDOMINIUM ASSOCIATION, BAYTHORNE TOWNHOME CONDOMINIUM ASSOCIATION and BAYTHORNE HOMEOWNERS ASSOCIATION, hereinafter collectively referred to as "BAYTHORNE".

WHEREAS, BAYTFORNE presently owns, controls and maintains Baythorne
Drive, a street extending from Kedzie Avenue on the Southwest to Flossmoor Road on

/as described on the attached Exhibit "A"
the North; and

WHEREAS, Baythorne Drive has become a commonly used connecting street between Kedzie Avenue and Flossmoor Road, and

WHEREAS, BAYTHORNE and FLOSSMOOK have agreed in principal to the dedication of Baythorne Drive as a public street; and

WHEREAS, as a condition of the dedication, FLOSSMOOR has required that BAYTHORNE assume responsibility for snowplowing of Baythorne Crive;

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein the parties hereto agree as follows:

- 1. FLOSSMOOR agrees to accept the dedication of Baythorne Drive as a public street in the Village of Flossmoor, subject to the provisions of this Agreement.
- 2. BAYTHORNE agrees, however, to retain responsibility for the snowplowing of Baythorne Drive, and to hold FLOSSMOOR harmless from any and all claims and demands arising out of their retained obligation for snowplowing, as hereinafter further provided.

- 3. BAYTHORNE agrees to hold the Village of Flossmoor harmless from any and all claims, demands and actions arising out of the snowplowing of Baythorne Drive after FLOSSMOOR accepts the dedication of Baythorne Drive as a public street.
- 4. BAYTHORNE agrees to cause its snowplowing contractor to name FLOSSMOOR as an additional insured party on all policies of insurance provided to BAYTHORNE by the snowplowing contractor, and further agrees to provide FLOSSMOOR with the proof of such insurance coverage prior to permitting any contractor to provide Baythorne Drive after it is accepted by the Village of Flossmoor.
- 5. BAYTHOPATE further agrees to cause BAYTHORNE'S liability insurance carrier to name the Village of Flossmoor as additional party insured to the extent of any claim arising out of BAYTHORNE'S obligation for snowplowing Baythorne Drive, or any other claim arising out of this Agreement, except for the sole negligence of Flossmoor, after it is accepted as a public farect in the Village of Flossmoor.

The insurance to be provided by BAYTHORNE shall provide first dollar defense, with limits for bodily injury and property damage of not less than one million (\$1,000,000.00) dollars per person and two million (\$2,000,000.00) dollars per occurrence. In addition to the above insurance, BAYTHORNE shall provide umbrella coverage of five million (\$5,000,000.00) dollars for one (1) year.

- 6. In the event of a breach by BAYTHORNE of any of the terms or provisions of this Agreement, which BAYTHORNE fails to cure within thirty (30) days of Notice to BAYTHORNE by FLOSSMOOR, then in that event, all interest of FLOSSMOOR in BAYTHORNE DRIVE shall revert to BAYTHORNE. Upon such reversion, all obligations of FLOSSMOOR under this Agreement shall cease and terminate.
- 7. The covenants, obligations, responsibilities, and liabilities of BAYTHORNE CONDOMINIUM ASSOCIATION, BAYTHORNE THOWNHOME
