## CITY OF CHICAGO'S NOTICE OF REGISTRATION OF ADMINISTRATIVE JUDGMENT

PLEASE TAKE NOTICE that the judgment creditor, City of Chicago, through its attorneys, Talan & Ktsaozs, Special Corporation Counsel, has registered an administrative judgment with the Circuit Court of Cook County, Illinois, as follows:

On, <u>02/14/06</u> administrative money judgment was rendered in the City of Chicago-Department of Administrative Hearings ("1'AH"), in favor of the plaintiff, City of Chicago, and against the defendant(s), <u>ROBERT BAROUD</u>, pursuant to Illinois law 65 ILCS 5/1-2.1-8, the defendant(s) either: (a) failed to seek administrative review within thirty-five (35) days of the administrative judgment; (b) sought administrative review and failed to over-turn the administrative judgment; or (c) sought administrative review but failed to seek or obtain a stay of the administrative money judgment. Accordingly, pursuant to 65 ILCS 5/1-2.1-8(c), the DAH judgment may be enforced in the same manner as a money judgment entered by a court of competent jurisdiction. The DAH judgment against the defendant(s), <u>FOBERT BAROUD</u>, is in the amount of <u>\$\$525.00</u>. Interest accrues on the administrative judgment at the rate of nine (9) percent per annum from <u>03/22/06</u> the thirty-fifth (35) day after the City of Chicago Department of Administrative Hearing rendered its administrative judgment.
