(g) Alteration or Removal. Not to remove, demolish of malerially after any part of the Property, without Lender's prior written consent, except Mortgagor may remove a fixture, provided the fixture is promptly replaced with another fixture of at least equal utility;

- 15. Assignment of Rents and Leases.
