


ORDER of Permanent Injunction

- ① ~~The~~ Defendants, their agents, heirs, successor or assigns, be permanently enjoined and restrained from renting, using, leasing or occupying the subject property at 6439-41 S. Defendants must keep the subject property boarded and secured while it is subject to this injunction.
