#### AGREED JUDGMENT ORDER PURSUANT TO STIPULATION

This matter is before the court upon the Complaint of the City of Chicago, a municipal corporation ("City"), for the ascertainment of just compensation to be paid for the property described therein, being Parcel 8-22, located at 2340 West Monroe, Chicago, Illinois; the Complaint to Condemn having been filed on July 17, 2003, and the City appearing by Mara S. Georges, Corporation Counsel and Rita Lewandowski. Assistant Corporation Counsel, its attorneys, and Defendant, Vera Wilkerson, appearing by William E. Ryan.

The Court finds that all Defendants to this proceeding have been served by process as provided by statute or have entered their appearances, and that the Court has jurisdiction of the subject matter of this proceeding and of all parties thereto; that the demond for trial by jury has been waived and that the City possesses the authority to exercise the right of eminent domain and such right is being properly exercised in this proceeding.

The Court having heard and considered the representations of counsel pursuant to the Stipulation for Agreed Judgment Order, finds that the owner or owners of and any parties interested in Parcel 8-22, legally described on Exhibit A attached hereto, are awarded as full and just compensation for the fee simple title to the aforesaid Parcel 8-22, the sum of Three Hundred and Eighty-FiveThousand and 00/100 (\$385,000.00).

"Just Compensation" as used in this Judgment shall include, but not be limited to the fair cash market value of the property acquired on the date of filing the Complaint for Condemnation, July 17, 2003.

### IT IS THEREFORE ORDERED, ADJUDGED AND DECREED:

- A. That the sum of Three Hundred and Eighty-Five Thousand and 00/100 (\$385,000.00) is herein awarded by the Court pursuant to the Stipulation for Agreed Judgment Order to the owner or owners of and party or parties interested in said real property described herein as Parcel 8-22.
- B. The City shall, within sixty (60) days from the entry of this Order, pay to the Treasurer of Cock County, Illinois, for the benefit of the Owner or Owners of Parcel 8-22 the sum of Three Hundred and Eighty-Five Thousand and 00/100 (\$385,000.00) as full just compensation for the taking of said parcel plus 6% interest from the date of this Order plus \$105.00 court costs.
- C. That upon payment, the City shall be vested with the fee simple absolute title to the property; and the City shall be authorized and empowered to enter upon and take immediate possession of the property. Upon deposit by the City of the condemnation award and statutory interest, all liens, including tax liens, chall attach to the award and shall be extinguished and void as to the Property.
- D. The Owner, Vera Wilkerson, represents there are no written leases on the subject property.
- E. That the Stipulation for Agreed Judgment Order is incorporated herein as if stated verbatim.
- F. There is no just reason for delaying the entry, enforcement or appeal from this Judgment Order.
