


EXHIBIT I

LEGAL DESCRIPTION

PARCEL 1: Lot 1 (except the North 17 feet thereof) in SOUTH HOLLAND HIGHLANDS, being a Subdivision in the Northwest 1/4 of Section 22, Township 36 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.
