THIS CAUSE COMING to be heard on the set call, the Court being fully advised in the premises and having heard evidence and testimony that the following items in the City's complaint are not complied to date:

IT IS HEREBY ORDERED THAT:

1. The judgment entered on the date of 11/18/99 in the amount of \$ 1000.00 plus \$60 court costs for a total of \$ 1060.00 against defendants Orleans Properties shall stand as final judgment and that leave for enforcement of said judgment is granted plaintiff, City of Chicago, instanter.
2. Defendant(s) Orleans Properties and his/her/their agents, heirs, successors or assigns must fully comply with the municipal code of the City of Chicago by 1/1/00
3. Defendant shall schedule and permit interior inspections of the subject premises to verify compliance with the terms of this order. Defendant shall call the inspector at 744-3435 or send written request to the Department of Buildings within 7 days after each compliance date stated in this order.
4. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction, including the adjudication of contempt proceedings if the permanent injunction is violated which could result in the imposition of a fine and/or incarceration.
5. This order is final and appealable, the court finding no just cause or reason to delay its enforcement.
