

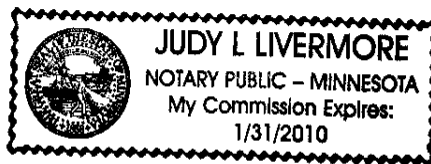

LEGAL DESCRIPTION
