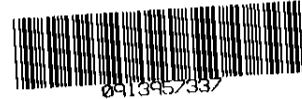

On 5/9/2009 the sale / Hyeon J. Kim's 2001 AUDI A-4 VIN# WAUAC68DX1A064741 will be held.

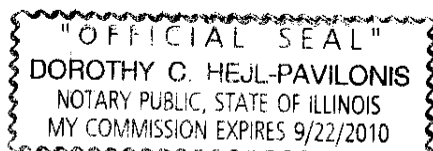
