MODIFICATION OF LOAN DOCUMENTS

THIS MODIFICATION Cr LOAN DOCUMENTS (this "Agreement") is made as of December 12, 2008, by and among Park Place on North Avenue, LLC, an Illinois limited liability company ("Park Place" or 'Initial Borrower"), Joseph Andriacchi, individually ("Joseph Andriacchi"), and Midwest Brik and Trust Company, not personally but as Trustee ("Trustee") under Trust Agreement dated December 23, 1992 and known as Trust No. 92-6419 ("92-6419 Trust"), under Trust Agreement dated June 8, 1984 and known as Trust No. 84-06-4434 ("84-06-4434 Trust"), under Trust Agreement dated January 12, 2005 and known as Trust No. 05-1-8353 ("05-1-8353 Trust") and as successor Trustee ("Trustee") to Midwest Trust Services, Inc., not personally but as Trustee under Trust Agreement dated July 28, 1998 and known as Trust No. 98-2-7373 ("98-2-7373 Trust") (92-641) Trust, 84-06-4434 Trust, 05-1-8353 Trust, and 98-2-7373 Trust are referred to collectively as the "Trusts") (Park Place and the Trusts are referred to collectively as the "Borrower"), Joseph Andriacchi ("Guarantor") and MIDWEST BANK AND TRUST COMPANY, an Illinois banking association, its successors and assigns ("Lender").

RECITALS:

- A. On or about December 12, 2007, Lender made a loan ("Loan") to Initial Porrower in the original principal amount of Two Hundred Thousand and no/100 Dollars (\$200,000.00), pursuant to the terms and conditions contained in that Business Loan Agreement ("Initial Loan Agreement") by and between Initial Borrower and Lender.
- B. The Loan is evidenced by a Promissory Note (the "<u>Initial Note</u>") dated December 12, 2007 in the original principal amount of the Loan made payable by Initial Borrower to the order of Lender.
- C. The Loan is secured by, among other things, (i) a Mortgage ("Initial Mortgage") dated December 12, 2007 executed by the 92-6419 Trust in favor of Lender and recorded on December 27, 2007 with the Cook County Recorder of Deeds ("Recorder's Office") as Document

No. 0736141145 creating a first lien on the property commonly knows as 9600 W. Golf Road (Lots 25, 26, 27 and 34), Des Plaines, Illinois and (ii) certain other loan documents.

- **D.** The Loan is further secured by (i) a Commercial Guaranty dated December 12, 2007 from Joseph Andriacchi to Lender and (ii) a Commercial Guaranty dated December 12, 2007 from Silvana Venditti-Andriacchi to Lender (collectively the "Guaranty").
- E. On or about February 6, 2008, Initial Borrower executed and delivered to Lender that Change in Terms Agreement ("2-6-08 Change in Terms Agreement"), pursuant to which, among other things, the loan rate was modified.
- F. On or about September 16, 2008, Initial Borrower executed and delivered to Lender that Promissory Note ("9-16-08 Note") payable to Lender in the principal amount of \$200,000.00.
 - G. Silvana Andriacchi died on November 9, 2008
- H. The Initial Borrower desires to modify the Loan Documents in order to, among other things, (i) extend the Maurity Date of the Note, (ii) modify the Interest Rate, (iii) add the Trusts as a co-Borrower, (iv) cross-collateralize and cross-default this Loan with other loans to Joseph Andriacchi, and (v) provide Lender with additional security for the Loan as detailed herein.
- I. Joseph Andriacchi has a financial interest in Park Place and is the beneficiary under the Trusts. Lender requires as a condition precedent to agreeing to modify the Loan Documents and entering into this Agreement that Joseph Andriacchi and the Trusts become co-Borrowers and Joseph Andriacchi and the Trusts have agreed to become co-Borrowers under the Loan.
- J. In consideration of Lender's agreeing to modify the Loan Documents and entering into this Agreement, Borrower agrees to execute and deliver to Lender (i) that Amended and Restated Promissory Note ("Amended Note") of even date herewith made payable by Park Place, and the Trusts as co-Borrowers payable to the order of Lender in the principal amount of the Loan, and (ii) such other documents, agreements, and certificates as Lender requests.
- K. The Initial Loan Agreement, the 2-6-08 Change in Terms Agreement, and this Agreement are referred to collectively as the "Loan Agreement". The Initial Note, the 9-16-08 Note and the Amended Note are referred to collectively as the "Note". The Note, the Mortgage, the Guaranty, and any other documents evidencing, securing and guarantying the Loan, in their original form and as amended, whether described herein or not, are sometimes collectively referred to herein as the "Loan Documents")

AGREEMENTS:

NOW, THEREFORE, in consideration of (i) the facts set forth hereinabove (which are hereby incorporated into and made a part of this Agreement), (ii) the agreements by Lender to

modify the Loan Documents, as provided herein, (iii) the covenants and agreements contained herein, and (iv) for other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- 1. <u>Maturity Date</u>. The Maturity Date of the Note is extended to December 12, 2009. Any reference in the Note, the Loan Agreement, the Mortgage, or any other Loan Document to the Maturity Date shall mean December 12, 2009.
- 2. <u>Interest Rate</u>. The Interest Rate is hereby modified as set forth, and defined in, the Amended Note.
- 3. <u>Principal and Interest</u>. Principal and interest shall be due and payable as set forth in the Note. As of the date hereof, the outstanding principal amount of the Loan is \$126,983.19.
- 4. <u>Co-Borrower</u>. The Trusts and Joseph Andriacchi hereby agree to become co-borrowers of the Loan and accept all liabilities and obligations under the Loan Documents as such co-borrower.
- Assignment of Leases and Rents. In order to further secure payment of the 5. Indebtedness and the observance, performance and discharge of the Obligations, Borrowers hereby absolutely and irrevocably assigns and transfers to Lender, all of Borrowers' right, title and interest in and to the leases and the rents, subject only to the Permitted Exceptions. Borrowers hereby appoint Lender its true and lawful attorney-in-fact, with the right, at Lender's option at any time, to demand, receive and enforce payment, to give receipts, releases and satisfactions, and to sue, either in Borrowers' or Leader's name, for all rents. Notwithstanding the foregoing assignment of leases and rents, so long as no Event of Default has occurred which remains uncured, Borrowers shall have a license to ecilect rents or other income from the Premises (such license to be deemed revoked upon the occurrence of an Event of Default) provided that the existence or exercise of such right of Borrowers shall not operate to subordinate this assignment to any subsequent assignment, in who'e or in part, by Borrower, and any subsequent assignment by Borrower shall be subject to the rights of the Lender hereunder. This Assignment shall not be deemed or construed to constitute Lender as a mortgagee in possession nor obligate Lender to take any action or to incur expenses or perform or discharge any obligation, duty or liability. Exercise of any rights under this Article 9 and the application of the rents to the Indebtedness or the Obligations shall not cure or waive any Event of Default.
- 6. <u>Cross Default and Cross Collateralization.</u> Each Trust hereby mortgages, grants, assigns, remises, releases, warrants, hypothecates and conveys to Lender, its successors and assigns, and grants a security interest in, the property, rights and interests legally owned by each such Trust, all of which property, rights and interests are hereby pledged primarily and on a parity with the real property owned by each such Trust and not secondarily. An Event of Default under any other Loan Documents with respect to any indebtedness owing by Joseph Andriacchi to Lender thereunder ("Other Loans") shall be an Event of Default with respect to this Loan, and upon the occurrence of an Event of Default, Lender shall have the right to exercise any and all remedies granted to Lender under this Agreement in accordance with the terms and conditions hereof. The collateral securing the Loan shall secure the Other Loans. The collateral securing the Other Loans shall also secure the Loan.

- 7. <u>Representations and Warranties of Borrowers</u>. Each Borrower hereby represents, covenants and warrants to Lender as follows:
 - (a) The representations and warranties in the Loan Agreement, the Mortgage and the other Loan Documents are true and correct as of the date hereof.
 - (b) There is currently no Event of Default (as defined in the Loan Agreement) under the Loan Agreement, the Note, the Mortgage, or the other Loan Documents and Borrowers do not know of any event or circumstance which with the giving of notice or passing of time, or both, would constitute an Event of Default under the Loan Agreement, the Note, the Mortgage, or the other Loan Documents.
 - (c) The Loan Documents are in full force and effect and, following the execution and delivery of this Agreement, they continue to be the legal, valid and binding obligations of Borrowers enforceable in accordance with their respective terms, subject to limitations imposed by general principles of equity.
 - (d) There has been no material adverse change in the financial condition of Borrowers or any other party whose financial statement has been delivered to Lender in connection with the Loan from the date of the most recent financial statement received by Lender.
 - (e) As of the date hereof, Borrowers have no claims, counterclaims, defenses, or set-offs with respect to the Loan or tle Loan Documents as modified herein.
 - (f) The Trust is validly existing under the laws of the State of its formation or organization and has the requisite power and suthority to execute and deliver this Agreement and to perform the Loan Documents as modified herein. The execution and delivery of this Agreement and the performance of he Loan Documents as modified herein have been duly authorized by all requisite action by or on behalf of the Trust. This Agreement has been duly executed and delivered on behalf of Borrowers.
- 8. <u>Title Policy</u>. As a condition precedent to the agreements contained herein, Borrower shall, at its sole cost and expense, cause Chicago Title Insurance Company to issue its title insurance policy (the "<u>Title Policy</u>"), together with such endorsements as Lender requires, as of the date this Agreement is recorded, reflecting the recording of this Agreement and insuring the first priority of the lien of the Park Place Mortgage, and the respective priorities of the New Mortgage, subject only to the exceptions set forth in the Title Policy as of its date of issuance and any other encumbrances expressly agreed to by Lender.
- 9. Reaffirmation of Guaranty. Joseph Andriacchi has agreed to become a co-borrower under the Loan. Notwithstanding the fact that Joseph Andriacchi is, as of the date hereof a co-borrower, Joseph Andriacchi as Guarantor ratifies and affirms the Guaranty in all respects agrees that the Guaranty is in full force and effect up to and including the date hereof following the execution and delivery of this Agreement. The representations and warranties of Guarantor in the Guaranty are, as of the date hereof, true and correct and Guarantor does not know of any default thereunder. The Guaranty is the valid and binding obligation of Guarantor through the date hereof, enforceable in accordance with its terms and Guarantor has no claims or defenses to

the enforcement of the rights and remedies of Lender thereunder, except as provided in the Guaranty. In addition, Guarantor hereby expressly and unconditionally waives, releases, and discharges any and all rights or claims under the Illinois Surety Act, 740 ILCS 155/0.01 et. seq. ("Illinois Surety Act"), and further acknowledges and agrees that Lender has no duty or obligation to Guarantor under the Illinois Surety Act.

10. <u>Expenses</u>. As a condition precedent to the agreements contained herein, Borrower shall pay all out-of-pocket costs and expenses incurred by Lender in connection with this Agreement, including, without limitation, title charges, recording fees, appraisal fees and attorneys' fees and expenses.

11. Miscelleneous.

- (a) This Agreement shall be governed by and construed in accordance with the laws of the State of Illinois.
- (b) This Agreement shall not be construed more strictly against Lender than against Borrowers or any guarantor merely by virtue of the fact that the same has been prepared by counsel for Lender, it being recognized that Borrowers, any guarantor and Lender have contributed substantially and materially to the preparation of this Agreement, and Borrowers, any guarantor and Lender each acknowledges and waives any claim contesting the existence and the adequacy of the consideration given by the other in entering into this Agreement. Each of the parties to this Agreement represents that it has been advised by its respective counsel of the legal and practical effect of this Agreement, and recognizes that it is executing and delivering this Agreement, intending thereby to be legally bound by the terms and provisions thereof, of its own free will, without promises or threats or the exertion of duress upon it. The signatories hereto state that they have read and understand this Agreement, that they intend to be legally bound by it and that they expressly warrant and represent that they are duly authorized and empowered to execute it.
- (c) Notwithstanding the execution of this Agreement by Lender, the same shall not be deemed to constitute Lender a venturer or partner of or in any way associated with Borrowers or any guarantor nor shall privity of contract be presumed to have been established with any third party.
- (d) Borrowers, any guarantor and Lender each acknowledges that there are no other understandings, agreements or representations, either oral or written, express or implied, that are not embodied in the Loan Documents and this Agreement, which collectively represent a complete integration of all prior and contemporaneous agreements and understandings of Borrowers, any guarantor and Lender; and that all such prior understandings, agreements and representations are hereby modified as set forth in this Agreement. Except as expressly modified hereby, the terms of the Loan Documents are and remain unmodified and in full force and effect.
- (e) This Agreement shall bind and inure to the benefit of the parties hereto and their respective heirs, executors, administrators, successors and assigns.

- (f) Any references to the "Loan Agreement", the "Note", the "Mortgage" or the "Loan Documents" contained in any of the Loan Documents shall be deemed to refer to the Loan Agreement, the Note, the Mortgage and the other Loan Documents as amended hereby. The paragraph and section headings used herein are for convenience only and shall not limit the substantive provisions hereof. All words herein which are expressed in the neuter gender shall be deemed to include the masculine, feminine and neuter genders. Any word herein which is expressed in the singular or plural shall be deemed, whenever appropriate in the context, to include the plural and the singular.
- This Agreement may be executed in one or more counterparts, all of (g) which when taken together, shall constitute one original Agreement.
- Time is of the essence of each of Borrowers' obligations under this (h) Agreement
- 12. Trustee Exculpation. This Agreement is executed by the Trustee, not personally but solely as Trustee as aforesaid, in the exercise of the power and authority conferred upon and vested in it as such Trustee, and it is expressly inderstood and agreed that nothing in this Agreement or the Note shall be construed as creating any liability on such Trustee personally to perform any express or implied covenant, condition or obligation under this Agreement or the Note, all such liability, if any, being expressly waived by every person or entity now or hereafter claiming any right, title or interest under this Agreement or the Note. Notwithstanding the foregoing, the Lender shall not be precluded from: (a) recovering any condemnation awards or insurance proceeds attributable to the curity depage ph Andriacchi a socuments.
