1. That she is the duly qualified and acting City Clerk of the City of Northlake, Cook County, Illinois, a Municipal Corporation.
2. That the City of Northlake, Cook County, Illinois, a Municipal Corporation, has supplied and is now supplying water and sewer facilities for the use of and at the expressed request of the owners, lessors, lessees and parties in possession of the following described real estate:
