MEMORANDUM OF COMPANY AUTHORITY

THIS MEMORANDUM OF COMPANY AUTHORITY ("Memorandum") is made and entered into as of this 10th day of April, 2009 by and among CONIX, INC., an Arizona corporation ("Member 1"), and CREC 100 INVESTORS, LLC, a Delaware limited liability company ("Member 2") and CREC 100, LLC, a Nevada limited liability company ("Company").

- 1. <u>Operating Agreement</u>. Member 1, Member 2 and the Company are parties to that certain Amended and Restated Operating Agreement of CREO 100, LLC, a Nevada limited liability company, dated as of April 3, 2009 (the "Operating Agreement").
- Limitations on Authority re: Sale of Property. Fursuant to Section 5.4 of the Operating Agreement, the written consent of both Member 1 and Member 2 is required for the Company to, and without such written consent the Manager may not, sell, convey, assign, encumber, mortgage or otherwise transfer, directly or indirectly, any property of the Company or any interest therein (a "Sale"). That shall be comprised of a written authorization signed by both Member 1 and Member 2, in form sufficient to confirm to third parties (e.g. bayers; escrow agents; title insurers) that the Manager is authorized to consummate a Sale of a specific Property and, if necessary, to be recorded in connection the closing of such Sale.
- 3. Recordation of Memorandum. Pursuant to Section 5.1 of the Operating Agreement, this Memorandum shall be recorded on the title of each Property owned by Company concurrent with the closing of the purchase of that Property for the purpose of providing notice of the provisions of Section 5.4 of the Operating Agreement limiting the Manager's authority to sell that property. Attached to this Memorandum as Exhibit "A" is a legal description of a Property owned by the Company.


