FORFEITUF E AGREEMENT

Pursuant to the Pretrial Release Order entered in the above-named case on Ma y 29, 2009, and for and in consideration of bond being set by the Court for defendant BRYANT ROBY in the amount of \$150,000 being partially secured by real property, ROSE LUMPKIN (GRANTOR) hereby warrants and agrees:

1. ROSE LUMPKIN warrants that she is the sole record owner and fineholder of the real property located at 142 South 18th Avenue, Maywood, Illinois, and described legally as follows:

ROSE LUMPKIN warrants that there are is one outstanding mortgage against the subject property and that her equitable interest in the real property approximately equals \$77,000.

- 2. ROSE LUMPKIN agrees \$77,000 of her equitable interest in the above-described real property, shall be forfeited to the United States of America, should the defendant BRYANT ROBY fail to appear as required by the Court or otherwise violate any condition of the Court's order of release. ROSE LUMPKIN further understands and agrees that, if the defendant BRYANT ROBY should violate any condition of the Court's release order, she will be liable to pay the difference between the bond amount of \$150,000 and her equitable interest in the property, and ROSE LUMPKIN hereby agrees to the entry of a default judgment against her for the amount of any such difference. ROSE LUMPKIN has received a copy of the Court's release order and understands its terms and conditions. Further, the surety understands that the only notice she will receive is notice of court proceedings.
- 3. ROSE LUMPKIN further agrees to execute a quitclaim deed in favor of the United States of America, which deed shall be held in the custody of the Clerk of the United States District Court, Northern District of Illinois, until further order of the Court. ROSE LUMPKIN understands that should defendant BRYANT ROBY fail to appear or otherwise violates any condition of the Court's order of release, the United States will obtain an order from the Court authorizing the United States to file and record the above-described deed, and to take whatever other action that may be necessary to perfect its interest in the above-described real property and satisfy the obligation arising from a breach of the bond.
- 4. ROSE LUMPKIN further agrees that she will maintain the subject property in good repair, pay all taxes and obligations thereon when due, and will take no action which could encumber

the real property or diminish her interest therein, including any effort to sell or otherwise convey the

property without leave of Court.

5. ROSE LUMPKIN further understands that if she has knowingly made or submitted

or caused to be made or submitted any false, fraudulent or misleading statement or document in

connection with this Forfeiture Agreement, or in connection with the bond set for defendant

BRYANT KOBY she is subject to a felony prosecution for making false statements and making a

false declaration vacer penalty of perjury. ROSE LUMPKIN agrees that the United States shall file

and record a copy of this corfeiture Agreement with the Cook County Recorder of Deeds as notice

of encumbrance in the amount of the bond.

ROSE LUMPKIN hereby declares under penalty of perjury that she has read the 6.

foregoing Forfeiture Agreement in its enturety, and the information contained herein is true and

correct. Failure to comply with any term or condition of this agreement will be considered a

violation of the release order authorizing the United States to request that the bond posted for the

release of the defendant be revoked.
