NINTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP THE SOUTHERN PINES CONDOMINIUM ASSOCIATION OF TINLEY PARK

NOW, THEREFORE, FIRST MIDWEST TRUST CO., formerly known as HERITAGE TRUST CO., as Trustee under Trust Agreement Trust No. 96-5798, dated March 4, 1996, as the legal

titleholder of the above described real estate, and The Southern Pines Company, Ltd., an Illinois corporation, and as purposes above set forth, declare that the above described real estate shall be hereinafter submitted to the provisions of the Condominium Act and to the provisions of the Declaration of Condominium Ownership for The Southern Pines Condominium Association of Tinley Park as fully set forth in Document No. 96-690099 recorded with the Recorder of Deeds for Cook County, Illinois.
