This Scrivener's Error Amendment is made and entered into this 5 day of MARCH, 2009, by the Owners of Units 401 through 410, inclusive (the "Affected Units" and "Owners of Affected Units" as applicable), Chicago University Commons VI, LLC an Illinois limited liability company (the "Declarant") and the Board of Managers of the University Commons VI Condominiums (the "Board").

WITNESSETH:

WHEREAS, Declarant submitted the real estate, legally described on Exhibit "A" attached hereto and incorporated herein (the "**Condominium Property**"), to the Illinois Condominium Property Act pursuant to the Declaration of Condominium for University Commons VI Condominiums which was Recorded on September 19, 2006 as document number 0626131055 (the "**Declaration**") [any capitalized terms herein shall be defined as in the Declaration]; and

WHEREAS, the Paragraph 13(e) of the Declaration provides for the Declarant's reserved the right to modify the Plat; and

WHEREAS, the First Annual Meeting of Unit Owners has occurred, however, Declarant hereby acknowledges and consents to recording of this Scrivener's Error Amendment; and

WHEREAS, Pages 10 and 11 of the Plat as originally Recorded include a scrivener's error with regard to the designations of the Affected Units; and

WHEREAS, the Illinois Condominium Property Act, pursuant to Section 27(b) thereof (765 ILCS 605/27(b)) provides generally for an association to correct scrivener's errors to the Declaration or other condominium instruments by recording an amendment to same, which amendment shall be approved by two-thirds (2/3) of the Board and the Owners of Affected Units.

DECLARANT DECLARE AS FOLLOWS:



1. Pages 10 and 11 of the Plat are hereby deleted and replaced with the revised pages 10 and 11, attached hereto as Exhibit B (the "**Revised Plat Pages**").
2. This instrument is executed by Chicago University Commons, VI, LLC, an Illinois limited liability company as aforesaid, in the exercise of the power and authority conferred upon and vested in it as such Limited Liability Company. All the terms, provisions, stipulations, covenants and conditions to be performed by Chicago University Commons VI, LLC are undertaken by it solely as the limited liability company aforesaid.
3. This instrument is executed by the Board, an Illinois not-for-profit corporation, by its authorized agent, in the exercise of the power and authority conferred upon and vested in it as such not-for-profit corporation. All the terms, provisions, stipulations, covenants and conditions to be performed by the Board are undertaken by it solely as aforesaid. The Board represents that not less than two-thirds (2/3) of the Board approved this Scrivener's Error Amendment.
4. This instrument is executed by the Affected Owners as indicated hereinafter.
5. Except as expressly set forth herein, the Declaration, shall remain in full force and effect in accordance with its terms. In the event and to the extent that this Scrivener's Error Amendment conflicts with the terms and provisions of the Declaration or any other Amendment to the Declaration, this Scrivener's Error Amendment shall be deemed to control. Notwithstanding the foregoing, this Scrivener's Error Amendment shall not be deemed to modify the legal description of the Condominium property or the schedule of percentage ownership which appear in the Declaration.
6. This Scrivener's Error Amendment may be executed in multiple counterparts, each of which shall be deemed to be and shall constitute one and the same instrument.
