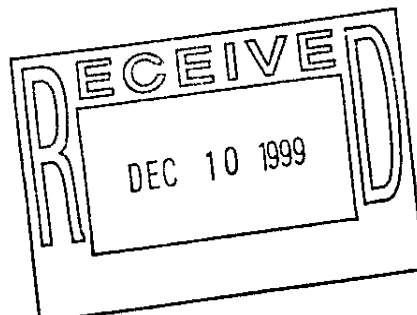
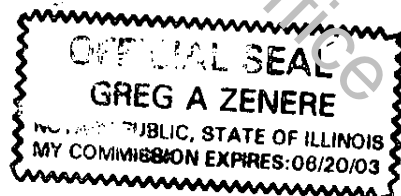

That part of the North 1/2 of the North West 1/4 of Section 30, Township 36 North, Range 15, East of the Third Principal Meridian, lying North and East of the North Easterly right-of-way line of the Pittsburgh, Cincinnati, Chicago and St. Louis Railroad Company, excepting therefrom (a) that portion of said premises conveyed to the South Chicago and Southern Railroad Company and excepting therefrom (b) that part falling in the following described property:

A parcel of land in the North west 1/4 of the North West 1/4 of Section 30, Township 36 North, Range 15, East of the Third Principal Meridian, bounded and described as follows:
