If the amounts of funds held by Lender at any time are not sufficient to pay the Escrow Items when due, Lender may notify the Borrower and require Borrower to make property as shortage as permitted by RESPA.

If this Security Instrument is on a leaseh at, Borrower shall comply with the provisions of the lease. 6. Condemnation. 14. Go erring Law; Severability. This Security Instrument shall be governed by Federal law and the law of the jurisdiction of which the Property is located. In the event that any provision or clause of this Security Instrument or the Note confects with applicable law, such conflict shall not affect other provisions of this Security Instrument or the Note which in the given effect without the conflicting provision. To this end the provisions of this Security Instrument and the Note are declared to be severable.

15. Borrower's Copy. Borr wer shall be given one conformed copy of the Note and of this Security Instrument.

16. Hazardous Substances Be rower shall not cause or permit the presence, use, disposal, storage, or release of any Hazardous Substances on rein the Property. Borrower shall not do, nor allow anyone else to do, anything affecting the Property that is in vicinit of any Environmental Law. The preceding two sentences shall not apply to the presence, use, or storage on the Property of small quantities of Hazardous Substances that are generally recognized to be appropriate to normal residential uses and to maintenance of the Property.

17. Assignment of Rents. Borrower unconditionally assigns and transfers to Lender .!! the rents and revenues of the Property. Borrower authorizes Lender or Lender's agents to collect the rents and revenues and hereby directs each tenant of the Property to pay the rents to Lender or Lender's agents.
