THIS THIKE AMENDMENT TO COVENANTS is made on or as of the day of location ("City"), 1999, by and between the CITY OF CHICAGO, an Illinois municipal corporation ("City"), 121 North LaSalle Street, Chicago, Illinois 60602, and WOODLAWN EAST COMMUNITY AND NEIGHBORS, INC., an Illinois not-for-profit corporation ("WECAN"), 6450 South Stony Island Avenue, Chicago, Illinois 60637.

RECITALS

WHEREAS, by quitclaim deed dated December 28, 1994, and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on December 30, 1994, as Document No. 04085915 ("Deed"), the City conveyed to WECAN the property legally described on Exhibit A attached hereto ("Property"); and

WHEREAS, the Deed contains a condition which runs with the land and which expressly provides that WECAN shall commence the rehabilitation, redevelopment or improvement of the Property ("Project") within sixteen months from the date of the Deed and shall complete the Project within twenty-four months from the date of the Deed; and

WHEREAS, WECAN has requested that the City grant it an extension of true in which to commence and complete the Project.

NOW, THEREFORE, in consideration of the foregoing and the mutual agreements and covenants of the parties, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. The first condition of the Deed is hereby amended to provide that WECAN shall commence the Project on or before January 31, 2000 and shall complete the Project on or before January 31, 2001.
- 2. This Third Amendment to Covenants shall supersede those provisions regarding the commencement and completion of the Project in: the unrecorded first amendment to covenants entered into between the parties dated September 27, 1996; the unrecorded Redevelop-

ment Agreement entered into between the parties dated December 20, 1991; and the Second Amendment to Covenants dated July 27, 1999, and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on August 9, 1999, as Document No. 99757167.
