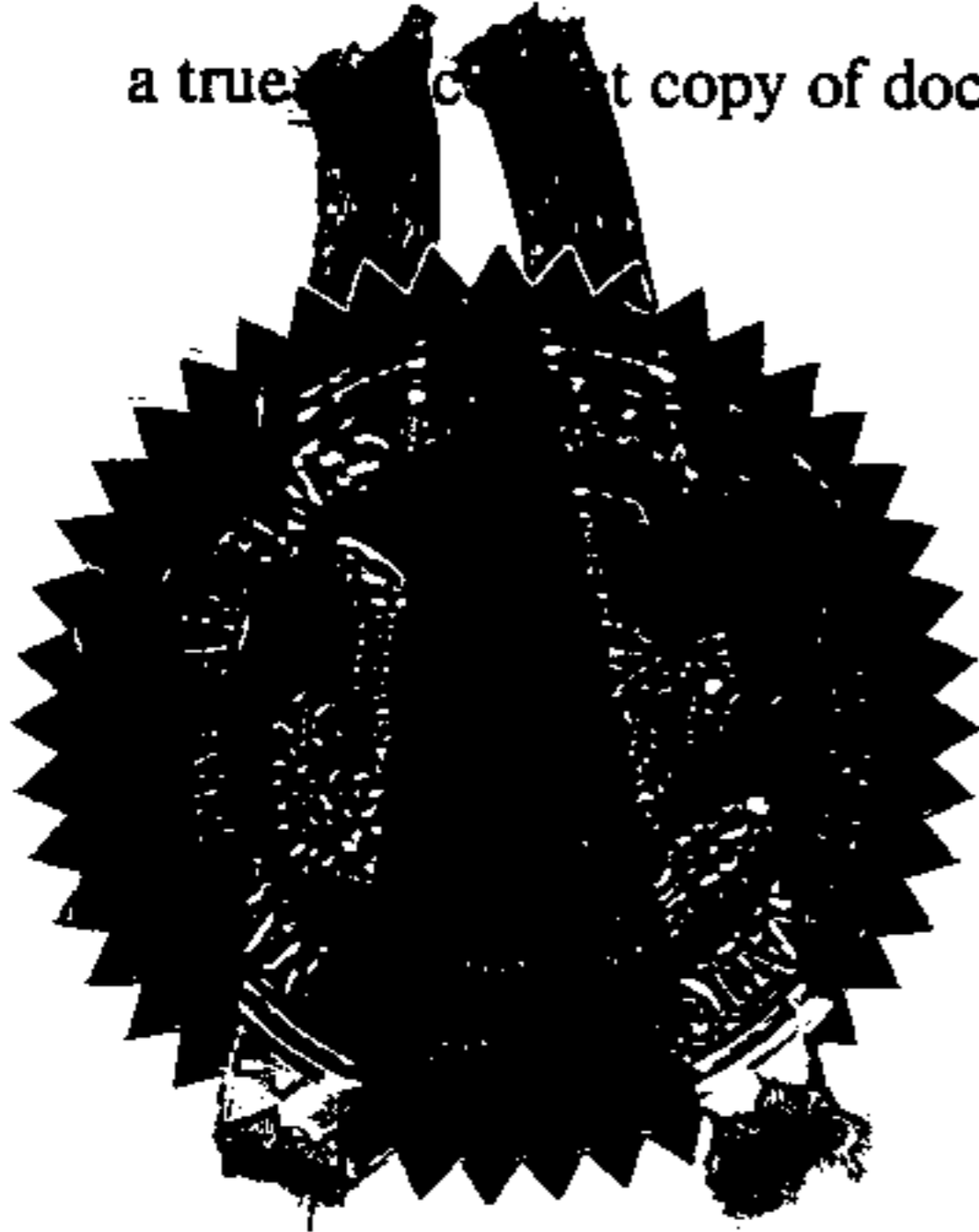

## DISCHARGE OF JOINT DEBTORS

It appears that the persons named above have filed a petition commencing a joint case under title 11, United States Code on October 23, 1995, that an order for relief was entered under chapter 7, and that no complaint objecting to the discharge of the debtors was filed within the time fixed by the court [or that a complaint objecting to discharge of one or both of the debtors was filed and, after due notice and hearing was not sustained].

### IT IS ORDERED THAT:

1. The above-named debtors are released from all dischargeable debts.
2. Any judgment heretofore or hereafter obtained in any court other than this court is null and void as a determination of the personal liability of the debtors with respect to any of the following:
  - (a) debts dischargeable under 11 U.S.C. § 523;
  - (b) unless heretofore or hereafter determined by order of this court to be nondischargeable, debts alleged to be excepted from discharge under clauses (2), (4), (6) and, in cases originally filed on or after October 22, 1994, (15) of 11 U.S.C. § 523(a);
  - (c) debts determined by this court to be dischargeable.
3. All creditors whose debts are discharged by this order and all creditors whose judgments are declared null and void by paragraph 2 above are enjoined from instituting or continuing any action or employing any process or engaging in any act to collect such debts as personal liabilities of the above-named debtors.
