This cause coming to be leard on Plaintiff Richard F. Smith International, Ltd.'s Verified Second Amended Complaint, the parties having agreed to the entry of judgment, and the Court having jurisdiction over the parties and subject matter,

THE COURT MAKES THE FOLLOWING FINDINGS OF FACT AND CONCLUSIONS OF LAW:

- Plaintiff has filed a Verified Second Amended Complaint alleging the following causes 1. of action against Sharon Wiseman: (1) Fraud - Count I; (2) Breach of Fiduciary Duty - Count II; (3) Conversion - Count III; (4) Tortious Interference with Prospective Economic Advantage - Count IV; and (5) Accounting and Constructive Trust – Count V;
- 2. Wiseman asserted the Fifth Amendment in response to the critical alegations contained in the Second Amended Complaint;
- 3. Wiseman pleaded guilty and was in fact found guilty in proceedings of theft and forgery relating to the embezzlement of monies from Plaintiff in People of the State of Illinois v. Sharon Wiseman, Case No. 97-26100 ("Criminal Action");

- 4. Wiseman now admits that she embezzled \$498,456.21 from Plaintiff through a fraudulent scheme while acting in a fiduciary capacity to Plaintiff;
- 5. Wiseman has paid \$88,069.81 in restitution through the Adult Probation Department to Plaintiff as part of her sentence in the Criminal Action;
 - 6. Wiseman has paid an additional \$6,000.00 to Plaintiff;
- 7. Plaintiff has received \$40,000 from American National Bank & Trust Co. ("ANB") in settlement of Plaintiff's claims against ANB in this litigation;
- 8. Plaintiff has received \$8,000.00 from Wiseman & Cohen, Numbers, Inc. ("Numbers") in settlement of Plaintiff's claims against Numbers in this litigation;
- 9. The parties seek a resolution of this matter through the entry of a judgment for the balance of the monies embezzled by Wiser and through a fraudulent scheme while acting in a fiduciary capacity to Plaintiff;
- 10. Wiseman acknowledges that because the monies were embezzled by her through a fraudulent scheme while acting in a fiduciary capacity to Plaintiff, this judgment is nondischargeable in bankruptcy pursuant to 11 U.S.C. § 523(a)(4);

IT IS HEREBY ORDERED:

1. Judgment is entered in favor of Plaintiff Richard F. Smith Interactional Ltd. and against Defendant Sharon Wiseman in the amount of \$356,386.40, plus interest at the statutory rate from the date of the execution of this judgment.
