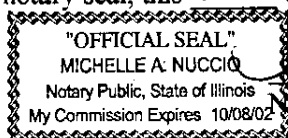

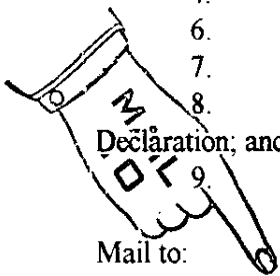
The tenant of Unit 1N &^{P-15} has waived or has failed to exercise the right of first refusal.

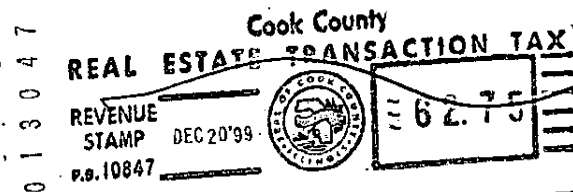
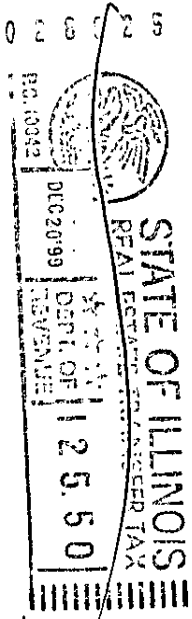
