WHEREAS, Edith Toni is the owner of record for units 510 and 512 in the Association; and


WHEREAS, Edith Toni desires to combine unit numbers 510 and 512 at the Association; and

- 4. Edith Toni is granted the exclusive use of the limited common elements appurtenant to the new unit number 512.
- 5. This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.
- 6. Except to the extent expressly set forth hereinabove. The remaining provisions of the Declaration shall continue in effect without change.
