This Agreement entered into as of the 1st day of December, 1999 between MORSE URBAN DEVELOPMENT, L.L.C., an Illinois limited liability company whose address is 401 North Michigan Avenue, Suite 2900, Chicago, Illinois 60611, whose sole members and their respective addresses are Morse Manager Corp., 401 North Michigan Avenue, Suite 2900, Chicago, Illinois 60611; CIG Morse, LLC, 401 North Michigan Avenue, Suite 2900, Chicago, Illinois 60611, Rogers Park Community Development Corp., an Illinois nonprofit corporation; and Parkway Bank and Trust Company, 48(0) Jorth Harlem, Harwood Heights, Illinois 60656, their successors, heirs, and assigns (jointly and severally, hereinafter referred to as Owners) and the undersigned Secretary of Housing and Urban Development and his successors (hereinafter referred to as Secretary).

In consideration of the endorsement to in urance by the Secretary of the above described note or in consideration of the consent of the Secretary to the transfer of the mortgaged property or the sale and conveyance of the mortgaged property by the Secretary, and in order to comply with the requirements of the National Housing Act, as amendor, and the Regulations adopted by the Secretary pursuant thereto, Owners 22003 for themselves, their successors, heirs and assigns, that in connection with the mortgaged property and the project operated thereon and so lorg as the contract of mortgage insurance continues in effect, and during such further period of time as the Secretary shall be the owner, holds or reinsurer of the mortgage, or during any time the Secretary is obligated to insure a mortgage on the mortgage property:

- Owners, except as limited by paragraph 17 hereof, assume and agree to make promptly all payments due under the note and mortgage.
- 2. (a) Owners shall establish or continue to maintain a reserve fund for replacements by the allocation to such reserve fund in a separate account with the mortgagee or in a safe and responsible depository designated by the mortgagee, concurrently with the beginning of payments towards amortization of the principal of the mortgage insured or held by the Secretary of an amount equal to 566.67 per month unless a different date or amount is approved in writing by the Secretary.

Such fund, whether in the form of a cash deposit or invested in obligations of, or fully guaranteed as to principal by, the United States of America shall at all times be under the control of the mortgagee. Disbursements from such fund, whether for the purpose of effecting replacement of structural elements and mechanical equipment of the project or for any other purpose, may be made only after receiving the consent in writing of the Secretary. In the event that the owner is unable to make a mortgage note payment on the due date and that payment cannot be made prior to the due day of the next such installment or when the mortgagee has agreed to forgo making an election to assign the mortgage to the Secretary based on a monetary default, or to withdraw an election already made, the Secretary is authorized to instruct the mortgagee to withdraw funds from the reserve fund for replacements to be applied to the mortgage payment in order to prevent or cure the default. In addition, in the event of a default in the terms of the mortgage, pursuant to which the loan has been accelerated, the Secretary may apply or authorize the application of the balance in such fund to the amount due on the mortgage debt as accelerated.

- (b) Where Owners are acquiring a project already subject to an insured mortgage, the reserve fund for replacements to be established will be equal to the amount due to be in such fund under existing agreements or charter provisions at the time Owners acquire such project, and payments hereunder shall begin with the first payment due on the mortgage after acquisition, unless some other method of establishing and maintaining the fund is approved in writing by the Secretary.
- Real property covered by the mortgage and this agreement is described in Schedule A attached hereto.

(This paragraph 4 is not applicable to cases insured under Section 232.)

- (a) Owners shall make dwelling accommodation and services of the project available to occupants at charges not exceeding those established in accordance with a rental schedule approved in anting by the Secretary, for any project subject to regulation of rent oy the Secretary. Accommodations shall not be rented for a period of less than thirty (3) days, or, unless the mortgage is insured under Section 231, for more than three years. Commercial facilities shall be rented for such use and upon such terms as approved by he Secretary. Subleasing of dwelling accommodations, except for subleases of single dwelling accommodations by the tenant the eof, shall be prohibited without prior written approval of Owners ar Tithe Secretary and any lease shall so provide. Upon discovery of any unapproved sublease, Owners shall immediately demand cancellation and notify the Secretary thereof.
- (b) Upon prior written approval by the Secretary, Owners may charge to and receive from any tenant such amounts as from time to time may be mutually agreed upon between the tenant and the Owners for any facilities and/or services which may be furnished by the Owners or others to such tenant upon his request. in addition to the facilities and services included in the approved rental schedule. Approval of charges for facilities and services is not required for any project not subject to regulation of cent by the Secretary.
- For any project subject to regulation of rent by the Secretary, the Secretary will at any time entertain a written request for a rent increase properly supported by substantiating evidence and within a reasonable time shall:

- (i) Approve a rental sthe lue tankis pecessary to compets to for any net increase, occurring since the last approved rental schedule, in taxes (other than income taxes) and operating and maintenance cost over which Owners have no effective control or;
- (ii) Deny the increase stating the reasons therefor.
- 5. (a) If the mortgage is originally a Secretary-held purchase money mortgage, or is originally endorsed for insurance under any Section other than Sections 231 or 232 and is not designed primarily for occupancy by elderly persons, Owners shall not in selecting tenants discriminate against any person or persons by reason of the fact that there are children in the family.
 - (b) If the mortgage is originally endorsed for insurance under Section 221, Owners shall in selecting tenants give to displaced persons or families an absolute preference or priority of occupancy which shall be accomplished as follows:
 - (1) For a period of sixty (60) days from the date of original offering, unless a shorter period of time is approved in writing by the sec etary, all units shall be held for such preferred applicants, after which time any remaining unrented units may be rered to non-preferred applicants;
 - (2) Thereafter, and on a continuing basis, such preferred applicants shall be given preference over nonpreferred applicants in their placement on a waiting list to be maintained by the Owners; and
 - (3) Through such further provisions agreed to in writing by the parties.
 - (c) Without the prior written approval of the Secretary not more than 25% of the number of units in a project insured (nder Section 231 shall be occupied by persons other than elderly persons.
 - (d) All advertising or efforts to rent a project insured under Section 231 shall reflect a bona fide effort of the Owners to obtain occupancy by elderly persons.
- 6. Owners shall not without the prior written approval of the Secretary:
 - (a) Convey, transfer, or encumber any of the mortgaged property, or permit the conveyance, transfer or encumbrance of such property.
 - (b) Assign, transfer, dispose of, or encumber any personal property of the project, including rents, or pay out any funds except from surplus cash, except for reasonable operating expenses and necessary repairs.
 - (c) Convey, assign, or transfer any beneficial interest in any trust holding title to the property, or the interest of any general partner in a partnership owning the property, or any right to manage or receive the rents and profits from the mortgaged property.
 - (d) Remodel, add to, reconstruct, or demolish any part of the mortgaged property or subtract from any real or personal property of the project.
 - (e) Make, or receive and retain, any distribution of assets or any income of any kind of the project except surplus cash and except on the following conditions:
 - (1) All distributions shall be made only as of and after the end of a semiannual or annual fiscal period, and only as permitted by the law of the applicable jurisdiction;

- distribution shall be made from borrowed funds, prior to the completion of the project or when there is any defaul under this Agreement or under the note or mortgage;
- (3) Any distribution of any funds of the project, which the part receiving such funds is not entitled to retain hereunder shall be held in trust separate and apart from any othe funds; and
- (4) There shall have been compliance with all outstanding notices of requirements for proper maintenance of the project.
- (f) Engage, except for natural persons, in any other business o activity, including the operation of any other rental project, o incur any liability or obligation not in connection with the project.

- (g) Require, as a condition of the occupancy or leasing of any uni in the project, any consideration or deposit other than the prepayment of the first month's rent plus a security deposit in at amount not in excess of one month's rent to guarantee the performance of the covenants of the lease. Any funds collected as security deposits shall be kept separate and apart from all other funds of the project in a trust account the amount of which shall at all times equal or exceed the aggregate of all outstanding obligations under said account.
- (h) Permit the use of the dwelling accommodations or nursing facilities of the project for any purpose except the use which wa originally intended, or permit commercial use greater than the originally approved by the Secretary.
- 7. Owners shall maintain the mortgaged premises, accommodation: and the grounds and equipment appurtenant thereto, in good repai and condition. In the event all or any of the buildings covered by the mortgage shall be destroyed or damaged by fire or other casualty, the money derived from any insurance on the property shall be applied in accordance with the terms of the mortgage.
- in i solvency or for reorganization or composition, or make any assignment for the benefit of creditors or to a trustee for creditors, or permit an adjudication in bankruptcy or the taking possession of the mortgaged property or any part thereof by a receiver or the seizure and sale of the mortgaged property or any part thereof under judicial process or pursuant any power of sale, and fail to have such adverse actions set aside within forty five (45) days.
- Any management contact entered into by Owners or any of them involving the project shall contain a provision that, in the event of default hereunder, it shall be subject to termination without penalty upon written request by the Secretary. Upon such request Owners shall immediately arrange to terminate the contract within a period of not more than thirty (30) days and shall make arrangements satisfactory to the Secretary for continuing proper management of the project.
 - (b) Payment for services, supplies, or materials shall not exceed the amount ordinarily paid for such services, supplies, or materials in the area where the services are rendered or the supplies or materials furnished.
 - (c) The mortgaged property, equipment, buildings, plans, offices, apparatus, devices, books, contracts, records, documents, and other papers relating thereto shall at all times be maintained in reasonable condition for proper audit and subject to examination and inspection at any reasonable time by the Secretary or his

- duly authorized agents. Own reschill keet copies of all writer contracts or other instruments which affect the mortgaged property, all or any of which may be subject to inspection and examination by the Secretary or his duly authorized agents.
- (d) The books and accounts of the operations of the mortgaged property and of the project shall be kept in accordance with the requirements of the Secretary.
- (e) Within sixty (60) days following the end of each fiscal year the Secretary shall be furnished with a complete annual financial report based upon an examination of the books and records of mortgagor prepared in accordance with the requirements of the Secretary, prepared and certified to by an officer or responsible Owner and, when required by the Secretary, prepared and certified by a Certified Public Accountant, or other person acceptable to the Secretary.
- (f) At request of the Secretary, his agents, employees, or attorneys, the Owners such furnish monthly occupancy reports and shall give specific answers to questions upon which information is desired from time to time relative to income, assets, liabilities, contracts, operation, and condition of the property ad the status of the insured mortgage.
- (g) All rents and other receipts of the project shall be deposited in the name of the project in a financial institution, whose deposits are insured by an agency of the Federal Sovernment. Such funds shall be withdrawn only in accordance with the provisions of this Agreement for expenses of the project of for distributions of surplus cash as permitted by paragraph 6(e) above. Any Owner receiving funds of the project other than by such cast biblition of surplus cash shall immediately deposit such funds it is project bank account and failing so to do in violation of this Agreement shall hold such funds in trust. Any Owner receiving property of the project in violation of this Agreement shall hold such funds in trust. At such time as the Owners shall have lost control and/or possession of the project, all funds held in trust shall be delivered to the mortgagee to the extent that the mortgage indebtedness has not been satisfied.
- (h) If the mortgage is insured under Section 232:
 - (1) The Owners or lessees shall at all times maintain in full force and effect from the state or other licensing authority such license as may be required to operate the project as a nursing home and shall not lease all or part of the project except on terms approved by the Secretary.
 - (2) The Owners shall suitably equip the project for nursing home operations.
 - (3) The Owners shall execute a Security Agreement and Financing Statement (or other form of chattel lien) upon all items of equipment, except as the Secretary may exempt, which are not incorporated as security for the insured mortgage. The Security Agreement and Financing Statement shall constitute a first lien upon such equipment and shall run in favor of the mortgagee as additional security for the insured mortgage.
 - (i) If the mortgage is insured under Section 231, Owners or lessees shall at all times maintain in full force and effect from the state or other licensing authority such license as may be required to operate the project as housing for the elderly.

- 10. Owner, will comply with the provisions of any Federal. State, colocal law prohibiting discrimination in housing on the grounds corace, color, religion or creed, sex, or national origin, including Title VIII of the Civil Rights Act of 1968 (Public Law 90-284: 82 Stat. 73 as amended, Executive Order 11063, and all requirements impose by or pursuant to the regulations of the Department of Housing an Urban Development implementing these authorities (including 2 CFR Parts 100, 107 and 110, and Subparts I and M of Part 200).
- 11. Upon a violation of any of the above provisions of this Agreement be Owners, the Secretary may give written notice thereof, to Owners, be registered or certified mail, addressed to the addresses stated in this Agreement, or such other addresses as may subsequently, upon appropriate written notice thereof to the Secretary, be designated be the Owners as their legal business address. If such violation is not corrected to the satisfaction of the Secretary within thirty (30) day after the date such notice is mailed or within such further time as the Secretary determines is necessary to correct the violation, without further notice the Secretary may declare a default under this Agreement effective on the date of such declaration of default and upo such default the Secretary may:
 - (a) (i) If the Secretary holds the note declare the whole of sai indebtedness immediately due and payable and then proceed with the foreclosure of the mortgage;
 - (ii) If said note is not held by the Secretary notify the holde of the note of such default and request holder to declare default under the not and mortgage, and holder after receiving such notice and request, but not otherwise, at its optior may declare the whole indebtedness due, and thereupo proceed with foreclosure of the mortgage, or assign the not and mortgage to the Secretary as provided in the Regula tions:

Collect all rents and charges in connection with the operation of the project and use such collections to pay the Owners' obligations under this Agreement and under the note and mortgage and the necessary expenses of preserving the property and operating the project.

- (c) Take possession of the project, bring any action necessary to enterce any rights of the Owners growing out of the project operation, and operate the project in accordance with the terms of this agreement until such time as the Secretary in his discretion detarmines that the Owners are again in a position to operate the project in a cordance with the terms of this Agreement and in compliance with the requirements of the note and mortgage.
- (d) Apply to any court, State or Federal, for specific performance of this Agreement, for an injunction against any violation of the Agreement, for the appointment of a receiver to take over and operate the project in accordance with the terms of the Agreement, or for such other relief as may be appropriate, since the injury to the Secretary arising from a default under any of the terms of this Agreement would be irreparable and the amount of damage would be difficult to ascertain.
- 12. As security for the payment due under this Agreement to the reserving fund for replacements, and to secure the Secretary because of his liability under the endorsement of the note for insurance, and a security for the other obligations under this Agreement, the Owner respectively assign, pledge and mortgage to the Secretary their right to the rents, profits, income and charges of whatsoever sort which they may receive or be entitled to receive from the operation of the

mortgaged property, subject, however to try assignment of exts in the insured mortgage referred to nerein. Until a default is declared under this Agreement, however, permission is granted to Owners to collect and retain under the provisions of this Agreement such rents, profits, income, and charges, but upon default this permission is terminated as to all rents due or collected thereafter.

- 13. As used in this Agreement the term:
 - (a) "Mortgage" includes "Deed of Trust", "Chattel Mortgage", "Security Instrument", and any other security for the note identified herein, and endorsed for insurance or held by the Secretary;
 - (b) "Mortgagee" refers to the holder of the mortgage identified herein, its successors and assigns;
 - (c) "Owners" refers to the persons named in the first paragraph hereof and designated as Owners, their successors, heirs and assigns;
 - (d) "Mortgaged Property" includes all property, real, personal or mixed, covered by the mortgage or mortgages securing the note endorsed for insurance or held by the Secretary;
 - (e) "Project" includes the mortgreed property and all its other assets of whatsoever nature or wheresoever situate, used in or owned by the business conducted on said mortgaged property, which business is providing housing and other activities as are incidental thereto;
 - (f) "Surplus Cash" means any cash remaining after:
 - (1) the payment of:
 - (i) All sums due or currently required to be paid und r the terms of any mortgage or note insured or held by the Secretary;
 - (ii) All-amounts required to be deposited in the reserve fund for replacements;
 - (iii) All obligations of the project other than the insured mortgage unless funds for payment are set aside or deferment of payment has been approved by the Secretary; and
 - (2) the segregation of:
 - (i) An amount equal to the aggregate of all special funds required to be maintained by the project; and
 - (ii) All tenant security deposits held.
 - (g) "Distribution" means any withdrawal or taking of cash or any assets of the project, including the segregation of cash or assets for subsequent withdrawal within the limitations of Paragraph 6(e) hereof, and excluding payment for reasonable expenses incident to the operation and maintenance of the project.

- n) "Default" means a default declared by the Secretary when a violation of this Agreement is not corrected to his satisfaction within the time allowed by this Agreement or such further time as may be allowed by the Secretary after written notice;
 - "Section" refers to a Section of the National Housing Act, as amended.
- (j) "Displaced persons or families" shall mean a family or families, or a person, displaced from an urban renewal area, or as the result of government action, or as a result of a major disaster as determined by the President pursuant to the Disaster Relief Act of 1970.
- (k) "Elderly person" means any person, married or single, who is sixty-two years of age or over.
- 14. This instrument shall bind, and the benefits shall inure to, the respective Owners, their heirs, legal representatives, executors, administrators, successors in office or interest, and assigns, and to the Secretary and his successors so long as the contract of mortgage insurance continues in effect, and during such further time as the Secretary shall be the owner, holder, or reinsurer of the mortgage, or obligated to reinsure the mortgage.
- 15. Owners warrant that they have not, and will not, execute any other agreement with provisions contradictory of, or in opposition to, the provisions hereof, and that, in any event, the requirements of this Agreement are paramount and controlling as to the rights and obligations set forth and supersede any other requirements in conflict therewith.
- 16. The invalidity of any clause, part or provisions of this Agreement shall not affect the validity or the remaining portions thereof.
 - The following Owners: Morse Urban Development, L.L.C., an Illinois limited liability company Do not assume personal liability for payments due under the note and mortgage, or for the payments to the reserve for replacements, or for the tiers not under their control, provided that said Owners shall remain liable under this Agreement only with respect to the matters hereinaft., stated; namely:
 - (a) for funds or property of the project coming into their hands which, by the provisions hereof, they are not entitled to retain; and
 - (b) for their own acts and deeds or acts and deeds of others which they have authorized in violation of the provisions hereof.

In further consideration of the endorsement for insurance by the Secretary of Housing and Urban Development ("HUD") of the note between Morse Urban Development, L.L.C. ("the Owner") and TRI Capital Corporation, dated as of December 1, 1999, and in order to comply with the requirements of the National Housing Act, as amended and the regulations adopted by the Secretary pursuant thereto, the Owner agrees as described below for itself, its successors, heirs and assigns, in connection with the mortgaged property and the project operated thereon and so long as the contract of mortgage in surance continues in effect and during such further period of time as the Secretary shall be the owner, holder, or reinsurer of the mortgage, or during any time the Secretary is obligated to insure a mortgage on the mortgaged property. The signatories to this document undertake the following obligations in their individual capacities as guarantors and as members or sponsors of the Owner, and the consideration described above runs to the signatories in both capacities. The following provisions are added to and made a part of the project Mortgage Note, Mortgage, and Regulatory Agreement, all dated as of December 1, 1999.

- 1. If any provision of the Articles of Organization, Operating Agreement, other organizational documents, or any later amendment to those documents of Morse Urban Development, L.L.C., an Illinois limited liability (ompany (the "LLC"), conflicts with the terms of the project loan documents (e.g., the note, mortgage, deed of trust, security agreement, security deed and/or the Regulatory Agreement), the provisions of the project loan documents will control.
- Notwithstanding any provision of state law to the contrary, any signatory to this rider receiving funds of the project other than by distribution of surplus cash as authorized in paragraph 6(e) of the Regulatory Agreement shall minediately deposit such funds in the project bank account and failing to do so in violation of this Agreement shall hold such funds in trust. Notwithstanding any provision of state law to the contrary, any signatory to this rider receiving property of the project in violation of this agreement shall immediately deliver such property to the project and failing to do so shall hold such property in trust.
- 3. Notwithstanding any provision of state law to the contrary, all signatories to this rider are liable for:
 - a. Funds or property of the project coming into their hands which, by the provisions hereof, they are not entitled to retain; and
 - b. Their own acts and deeds or acts and deeds of others which they have authorized in violation of the provisions of the Regulatory Agreement;
- 4. Notwithstanding any provision of state law to the contrary, any member-manager, member with governance interests equaling or exceeding 10 percent, or member with financial interests equaling or exceeding 25 percent, who, as of December 1, 1999, the date of the Regulatory Agreement, include the following: Morse Manager Corp., CIG Morse, LLC, Parkway Bank and Trust Company and Rogers Park Community Development Corp. shall be liable, in the amount of any loss, damage or cost (including but not limited to attorneys' fees) resulting from fraud or intentional misrepresentation by the mortgagor, the mortgagor's agents or employees, or a member of mortgagor in connection with obtaining the loan evidenced by the note, or in complying with any of the mortgagor's obligations under the loan documents.
- 5. All signatories to this rider will be considered agents of the Owner for the purpose of establishing liability under the double damages provision at 12 U.S.C. §1715z-4a and the equity skimming penalty under 12 U.S.C. §1715z-19, unless HUD agrees in writing to the contrary.

- Each signatory to this rider will be individually liable for payment of the entire amount of any civil money penalty imposed on the mortgagor pursuant to Section 537 of the National Housing Act, 12 U.S.C. §1735f-15.
- The owner has designated Morse Manager Corp. as its official representative for all matters concerning the project which require HUD consent or approval. The signature of this person will bind the Owner in all such matters. The Owner may from time to time appoint a new representative to perform this function, but within 3 business days of doing so, will provide HUD with written notification of the name, address, and telephone number of its new representative. When a member other than the member identified above has full or partial authority for management of the project, the owner will promptly provide HUD with the name of that member and the nature of that member's management authority.
- Notwithstanding any provision of state law to the contrary, no signatory to this rider shall have a sy right of subrogation or indemnification against the Owner or the property of the project by reason of any payment made or liability incurred pursuant to this rider or any statute to which this rider refers.
- 9 Noty unstanding any other provision contained herein or in the Mortgage Note, the Mortgage or the Regulacry Agreement to the contrary, it is agreed that the execution of this Rider shall impose no personal lability upon the Mortgagor or the LLC or any member thereof, whether as a member or individually, for payment of the indebtedness evidenced by the Mortgage Note and in the event of a default, the lol let thereof shall look solely to the property subject to the Mortgage and to the rents, issues and profits thereof in satisfaction of the indebtedness evidenced by the Mortgage Note and will not seek or obtain any deficiency or personal judgment against the Mortgagor or the LLC or any member to ereof, whether as a member or individually, with respect to such indebtedness, except such judgment or decree as may be necessary to foreclose or bar its interest in the property subject to the Mongage and all other property mortgaged, pledged, conveyed or assigned to secure payment of the note, provided, that nothing in this condition and no action so taken shall operate to impair any obligation of the Mortgagor or the LLC or any member thereof, tory
