The undersigned claimant, Bes' way Remodeling and Decorating, LLC, a corporation duly organized and existing under Illinois law and having its principal place of business at 8832 South Harper, Chicago, County of Cook, Illinois 60619, claims a mechanics' lien on the lot of land described below and improvements on the land under the Illinois Mechanics' Lien Act (770 ILCS 60/0.01 to 60/39). - 2. The undersigned claimant entered into a written contract with the owner on October 17, 2008. Under this contract, claimant agreed to perform work, labor services and deliver material and fixtures, including but not limited to repair, remodel and/or paint the basement, kitchen, bathroom, front porch, certain windows, all walls, flooring, soffits, gutters, garage, HVAC, electric and plumbing in the improvement of the premises for \$78,600.00, plus any extras that might be contracted for from time to time.
- 3. Claimant completed the furnishing and performance of all work, labor and services and delivered all material and fixtures required by contract.
- 4. At the owner's request, claimant contracted to and did furnish and perform additional work, labor and services on, and to deliver extra material and fixtures to, the premises for the amount of \$2,500.00.
- 5. All of the work, labor, services, material and fixtures was furnished, performed, delivered to and used, in the premises' improvement. The last of the work, labor, services, material, and fixtures, including extras, was delivered and furnished, and the contract was completed on March 27, 2009.
- 6. \$14,775.00 is due to claimant for the furnishing, performance, and delivery of the work, labor, services, material and fixtures, including extras, after allowing the owner all credits, deductions and set-offs.
- 7. Claimant now claims a mechanics' lien on the premises and all improvements described above against all persons interested in the premises for \$14,775.00, together with interest, according to the Mechanics' Lien Act.
