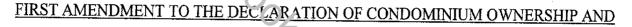

#### BY-LAWS EASEMENTS, RESTRICTIONS AND CONVENANTS FOR BAYPOINT

#### CONDOMINIUM ASSOCIATION

WHEREAS, the Unit owners and Baypoint Condominium Association hold legal to title to the real estate situated in the City of Chicago, Cook County, Illinois, legally described as follows:

WHEREAS, by Section 5 of Article XIX of the Declaration, the Declaration may be amended by an instrument in writing setting forth such amendment which is signed and acknowledged by all members of the Board, at least three-fourths (3/4) of the Residential Unit Owners, the Commercial Unit Owner, and approval of any mortgagees of any Unit required under pursuant the Condominium Instruments; and

WHEREAS, by Section 1 of the Article XIX approval of mortgagees is not required for the adoption of an amendment to the Declaration which does not change the undivided interests of the Units in the Common Elements; and;

NOW, THEREFORE, the Unit Owners, for the purposes above set forth, DECLARES AS FOLLOWS:

1. The Declaration is hereby amended by deleting Article IX in its entirety and in place thereof inserts the following as Article IX:

#### **ARTICLE IX**

#### SALE, LEASING OR OTHER ALIENATION

- 1. Sale or Leace. Any Unit Owner, other than the Declarant, who wishes to sell or lease its Unit, or any owner of the beneficial interest in a Unit who wishes to sell or assign said beneficial interest or any lessee of any Unit wishing to assign such lease or sublease such Unit, shall give to the Loard, not less than sixty (60) days' prior to the contemplated closing of such sale, assignment, commencement of such lease or sublease, or effective date of such assignment, the name, and address, of the proposed purchaser, assignee, lessee, sublessee or assignee, and such other information concerning the proposed purchaser, assignee, lessee, sublessee or assignee as the Board may reasonably require.
- 2. Gift. Any Unit Owner, other than the Declarant, who wishes to make a gift of its Unit or any interest therein, shall give to the Board not less than sixty (60) days' prior to the contemplated effective date of such gift, written notice of its intent to make such gift, together with the name, address, of the intended done and such other information concerning the intended done as the Board may reasonably require.
- 3. <u>Devise.</u> In the event any Unit Owner dies leaving a will devising his or her Unit or any interest therein to any Person or Persons not heirs-at-law of the deceased Unit Owner under the Rules of Descent of the State of Illinois, and said will is admitted to probate, the name and address of the heirs at law, devisees, and or administrator shall be provided to the board by the individual(s) that may have said information.
- 4. <u>Judicial and Execution Sales</u>. In the event any Unit or interest therein is sold at a judicial or execution sale (other than a mortgage foreclosure sale), the Person acquiring title through such a sale shall give to the Board, not less than sixty (60) days' prior to taking possession of such Unit, written notice of its intent to take possession of such Unit, together with such Person's name, address, and such other information concerning such Person as the Board may reasonably require.
- 2. In all other respects, the Unit Owners and Baypoint Condominium Association confirm the Declaration reserving their right to further amend the Declaration and any amendments thereto.
