ATTACHMENT TO UCC FINANCING STATEMENT DESCRIPTION OF COLLATERAL

The Pettor hereby mortgages, grants, assigns, remises, releases, warrants and conveys to the Secured Petty, its successors and assigns, and grants a security interest in, the following described property, rights and interests (referred to collectively herein as the "<u>Premises</u>"), all of which property, rights and interests are hereby pledged primarily and on a parity with the Real Estate (as defined below) and not secondarily:
