ORDER

For the reasons set forth in a Memorandum Opinion dated March 31, 2009, the Court grants the motion of U.S. Bank National Association, as Trustee and finds that L.D.S., L.L.C. violated the automatic stay pursuant to 11 U.S.C. § 362(a)(4) when it obtained and recorded its memorandum of judgment. The Court den es the request of L.D.S., L.L.C. to annul the stay retroactively under 11 U.S.C. § 362(d). As a result of L.D.S., L.L.C.'s violation of the automatic stay, the Court voids its memorandum of judgment ab initio. The Court will not grant U.S. Bank National Association, as Trustee any relief under 11 U.S.C. § 362(n) because the stay violation was not willful, and U.S. Bank National Association, as Trustee is not an in dividual. Thus, U.S. Bank National Association, as Trustee is not able to recover any damages, fees, or costs.
