Service or benefits were rendered to the above property by the District for the months of January through May 2009 in the amount of \$2,289.43, including interest and penalty, together with any additional accrued interest to date, as provided for in said Ordinance.

Said amount is delinquent and became delinquent at various times in accordance with said bill, a copy of which is attached hereto as Exhibit B (less any credits due or amounts paid on account), and the terms of this Ordinance.


