

Any amounts disbursed by Lender under this Section 9 shall become additional debt of Borrower secured by this Security Instrument. The e amounts shall bear interest at the Note rate from the date of disbursement and shall be payable with such interest, upon notice from Lender to Borrower requesting payment.
