Such maintenance shall include the sections of the Building Roof over the respective Units. Notwithstanding any other provision in the Declaration, the maintenance, repairs and replacement of the Building Roof over the respective Units shall be furnished by the Board as part of the Common Expenses, subject to the By-Laws or rules and regulations of the Association.
