EXHIBIT B

TO MULTIFAMILYMORTGAGE AND TO FINANCING STATEMENTS

DESCRIPTION OF COLLATERAL

As used herein, the term "Borrower" shall mean and include the terms "Mortgagor," "Grantor," and "Debtor."

Thir Exhibit B is attached to, and incorporated by reference in, one or more documents executed and delivered by Borrower in connection with financing for the Project (hereinafter defined), including (i) a Multifamil' Mortgage, Assignment of Rents and Security Agreement (the "Mortgage"), and (ii) one or more Uniform Commercial Code Financing Statements.
