NOW COMES THE CITY OF EVANSTON, an Illinois municipal corporation, 2100 Ridge Avenue, Evanston, Illinois 60201, by Jeffrey Murphy, Assistant Director, Property Standards/Housing Rehabilitation and claims a lien in the amount of Six Hundred Sixty-Eight Dollars and 00/100 (\$668.00). Said lien is claimed pursuant to the police powers of a home rule unit of local government to protect the public health, welfare, and safety by closing and securing said structure when its condition imperils life, safety, or health.




