- The quantity of water for which this lien is filed is approximately 33 thousand cubic feet. 4.
- 5. The amount due for water service is \$631.22.
- Sewer service was furnished to the herein described property by the Claimant, at the rate provided by 6. Title 3, Chapter 12 of the Code.
- 7. The amount due for sewer service is \$410.81.
- 8. The total amount due the Claimant is \$1,042.03.


