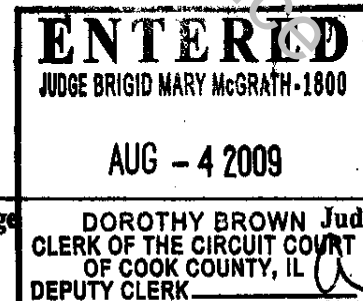

MEMORANDUM OF JUDGMENT (Page 2 of 2)

Pursuant to the judgment order, irrespective of the aggregate sum of the judgment amounts awarded against Donald F. Zordani, Jr. on counts III through V of the Complaint, his total judgment liability is limited to \$5,447,000, plus all applicable post-judgment interest. The total judgment debt on counts III through V is \$15,647,634.63, as detailed below:

On Count III of the Complaint in the amount of \$5,457,285.36 plus \$1,227.29 per day from December 18, 2008, totaling \$5,611,923.90 through the date of judgment, jointly and severally with Maurice W. Mihelich, Diane M. Mihelich, and Jan M. Zordani.

On Count IV of the Complaint in the amount of \$3,257,291.49 plus \$672.22 per day from December 18, 2008, totaling \$3,341,991.21 through the date of judgment, jointly and severally with Maurice W. Mihelich, Diane M. Mihelich, Jan M. Zordani, Milestone Development, LLC, and Hogblom LLC.

On Count V of the Complaint in the amount of \$6,524,417.10 plus \$1,343.67 per day from December 18, 2008, totaling \$6,693,719.52 through the date of judgment, jointly and severally with Maurice W. Mihelich, Diane M. Mihelich, Jan M. Zordani, Milestone Development, LLC, and Hogblom LLC.
