**MAXIMUM LIEN.** At no time shall the principal amount of Indebtedness secured by the Mortgage, not including sums advanced to protect the security of the Mortgage, exceed \$68,000.00.

**THIS MORTGAGE** dated July 30, 2009, is made and executed between Genesis 1, LLC, An Illinois Limited Liability Company, whose address is 3108 S Route 59, Ste 124-260, Naperville, IL 60564 (referred to below as "Grantor") and First Personal Bank, whose address is 14701 Ravinia Ave, Orland Park, IL 60462 (referred to below as "Lender").
