Central Park Avenue, Skokie, Illinois 60076 on account of an unpaid Late Filing Fee, Invoice No. 12394-2009-C-005, pursuant to Section 10 of the Sewage and Waste Control Ordinance of the METROPOLITAN WATER RECLAMATION DISTRICT OF GREATER CHICAGO.

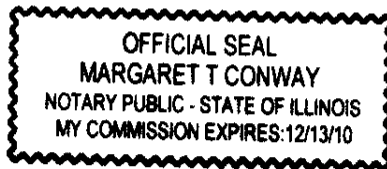
**WHEREFORE**, the District does hereby claim a lien for the amount of said delinquencies against the real estate described herein.

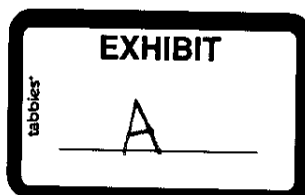
