AN ORDINANCE ESTABLISHING VILLAGE OF SCHAUMBURG SPECIAL SERVICE AREA NUMBER 12

BE IT ORDAINED by the President and Board of Trustees of the Village of Schaumburg, Cook County, Illinois, as follows:

SECTION 1: AUTHORITY. Village of Schaumburg Special Service Area Number 12 (herein fer "Special Service Area Number 12") is established pursuant to the provisions of Article VII, Section 6 of the Constitution of the State of Illinois; and pursuant to the provisions of the Special Service Area Tax Law, 35 ILCS 200/27-5 et seq.

SECTION 2: FINDINGS.

- Resolution Number 09-R-234 pursuant to which Cook County, in accordance with 35 ILCS 200/27-5, consented to the creation of Special Service Area Number 12 and the Village of Schaumburg's (hereinafter the "Village") inclusion of an unincorporated parcel of property, commonly known as 400 East Monterey Avenue, Roselle (unincorporated), Illinois 60193, in Special Service Area Number 12; said unincorporated parcel being legally described on Exhibit 1 attached hereto and made part hereof, and depicted on Exhibit 2 attached hereto and made part hereof.
- B. The question of the establishment of the area hereinafter described as a special service area was considered by the President and Board of Trustees (hereinafter the "Village Board") of the Village pursuant to an Ordinance

entitled: "An Ordinance Proposing the Establishment of Special Service Area Number 12 in the Village of Schaumburg and providing for a Public Hearing and Other Procedures in Connection Therewith," adopted May 12, 2009, and was considered pursuant to a public hearing held on June 9, 2009, by the Village Board pursuant to a Newspaper Notice duly published in The Daily Herald, a newspaper published in the Village, at lean ifteen (15) days prior to the public hearing, and pursuant to Personal Notice by mail addressed to the person or persons in whose name the general taxes for the last preceding year were paid on each lot, block, tract or parcel of land lying within Special Service Area Number 12. Said Personal Notice by mail was given by depositing said Personal Notice in the United States mails not less than ten (10) days prior to the time set for the public hearing. In the event taxes for the last preceding year were not paid, the said Personal Notice was sent to the person last listed on the tax rolls prior to that year as the owner of said property. A Certificate of Publication of said Newspaper Notice and an Affidavit of Mailing of said Personal Notice are attached to this Ordinance as Exhibit 3 and Exhibit 4, respectively, and made part hereof. Said Newspaper Notice and Fersonal Notice conformed in all respects to the requirements of Section 27-25 of the Special Service Area Tax Law (35 ILCS 200/27-25).

C. That a public hearing on the question set forth in the Newspaper Notice and Personal Notice was held on June 9, 2009. All interested persons

were given an opportunity to be heard on the question of the creation of Special Service Area Number 12, the making of a loan by the Village to finance the costs of the proposed special services (the construction of new watermains to service the properties within Special Service Area Number 12), the levy of an annual tax to pay the interest on said loan and the principal thereof at maturity, as set forth in the Newspaper Notice and Personal Notice. The public hearing was opened at 8:01 p.m., with final adjournment thereof at 8:20 p.m., all on June 9, 2009.

- D. That more than sixty (60) days have passed since the public hearing, and no objections to the establishment of Special Service Area Number 12 have been filed with the Village
- E. That after considering the data. Is presented at the public hearing, the Village Board finds that it is in the public interest and in the interest of Special Service Area Number 12 that said Special Service Area Number 12, as hereinafter described, be established.
- F. Said Special Service Area Number 12 is compact and contiguous and exists in a residential area within the Village, and within unincorporated Cook County (as noted in subsection A above).
- G. It is in the best interest of said Special Service Area Number 12 that the furnishing of the municipal services proposed be considered for the common interests of said Special Service Area Number 12.

H. Said Special Service Area Number 12 is zoned for residential purposes and will benefit specially from municipal services proposed to be provided. The proposed municipal services are unique and in addition to the municipal services provided to the Village as a whole.

SECTION 3: VILLAGE OF SCHAUMBURG SPECIAL SERVICE AREA NUMBER 12 ESTABLISHED.

A special service area to be known and designated as "Village of Schaumburg Special Service Area Number 12" is hereby established and shall consist of the following described territory:

Lots1 through 10, inclusive, and Lot 15 in Block 1; Lots 1, 2 and 5 in Block 2; Los 1 through 7, inclusive, in Block 3; all in Branigar's Meadow Knolls, a subdivision of part of the North ½ of Section 34, Township 41 North, Range 10, East of the Third Principal Meridian, and part of the Southwest 1/4 of Section 27, Township 41 North, Range 10, East of the Third Principal Meridian; also Lots 6, 2 and 10 in Block 13 in Branigar's Meadow Knolls Unit No. 2, 2 subdivision of part of the Northeast 1/4 of Section 34, Township 41 North, Range 10 East of the Third Principal Meridian, and part of the Northwest 1/4 of Section 35, Township 41 North Range 10, East of the Third Principal Meridian; also Lot 26 in Eranigar's Medinah Sunset Hills, a subdivision in the Northwest 4 of Section 35, Township 41 North, Range 10, East of the Third Principal Meridian; along with those portions of Sumn it Drive, Crest Court, Greenview Court, Niagara Avenue, Crest Street, and located adjacent thereto; all in Cook County, Illinois;

An accurate map of the above-described territory is attached hereto as <u>Exhibit 5</u>, and made part hereof.

SECTION 4: PURPOSE OF SPECIAL SERVICE AREA. Special Service Area Number 12 is established to provide special municipal services to the properties within Special Service Area Number 12 in addition to services provided to the Village generally. Included in said services shall be the construction of new watermains to service the properties within Special Service Area Number 12. Special Service Area Number 12 is also created so that a Village loan may be made, for the purposes aforesaid, payable from taxes levied on property in Special Service Area Number 12 in addition to all other Village taxes so levied.

In regard to the financing of the costs of said new watermain construction, the Village shall provide a loan in an amount of not to exceed two hundred forty-five thousand and no/100 dollars (\$245,000.00), to be retired over not to exceed a fifteen (15) year period and to bear interest at a rate of not to exceed four and one-half percent (4.5%) per annum. Said loan shall be retired by the levy of a direct annual tux at a tax rate sufficient to pay the interest on such loan as it falls due and to discharge the principal thereof at maturity, with said tax to be levied upon all taxable property within Special Service Area Number 12 at a maximum rate not to exceed the rate necessary to pay the debt service on the aforementioned loan.

The aforementioned taxes shall be in addition to all other taxes provided by law.

SECTION 5: EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as required by law. The Village Clerk is hereby directed and ordered to file a certified copy of this Ordinance with the Cook County Clerk, and record a certified copy of this Ordinance with the Cook County Recorder's Office, within sixty (60) days of the effective date hereof.



Schaumburg Special Service Area Number 12 (Meadow Knolls Subdivision Watermain - East)


Unincorporated Parcel

The hearing may be adjourned by the President and Board of Trustees to another date without further notice other than a motion to be entered upon the minutes of its meeting, fixing the time and place of its adjournment and/or as otherwise required by law.

If a petition signed by at least time-one percent (51%) of the electors residing within Special Service Area Number 12 and by at least fifty-one percent (51%) of the owners of record of the land included within the Loundaries of Special Service Area Number 12 is filed with the Village Clerk, within sixty (60) days following the final adjournment of the public hearing, objecting to the creation of Special Service Area Number 12, the levy or public hearing, objecting to the creation of Special Service Area Number 12, the levy or imposition of a tax or the issuance of a loan from the Village for the provision of special services to the area, or to a proposed increase in the tax rate, said Special Service Area Number 12 may not be created, and no tax may be levied or imposed nor the rate increased.
