WHEREAS, both Klaucens and the Salvation Army were deeded parking crace 61, a limited common element of the above-stated Association;

WHEREAS, Norbert Klaucens and his predecessors in title to the properly, Thomas A. Manion and Nicole Y. Klaucens, have parked in parking space P-53 since the property was purchased by Thomas A. Manion and Nicole Y. Klaucens on or about October 2, 2003;

WHEREAS, the Declaration of Condominium Ownership and Easements, Restrictions, Covenants and By-Laws for Wolfram Towers Homeowners Condominium Association recorded December 14, 2000 as document number 00984625, as amended from time to time, does not state which units are assigned parking spaces P-61 and P-53;

WHEREAS, Klaucens desires to continue to use parking space P-53 and to convey to his successors in interest said parking space upon sale of Unit 511;

WHEREAS, the Salvation Army desires to continue to use parking space P-61;

WHEREAS, Klaucens, the Salvation Army and Association consent to such use of the rarking spaces;

WHEREAS, Association has checked its records and its records indicate that Unit 511 has the exclusive use of parking space P-53, and Unit 415 has the exclusive use of parking space P-51;

WHEREAS, Marcens and Association hereby agree that all of the terms and conditions of this Agreement shall run with and encumber Unit 511 with the legal description as attached hereto as Exhibit A-1.

### AGREEMENT

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties covenant and agree hereby as follows:

- 1. The recitations set forth in the foregoing Recitals are material to this Agreement and are expressly incorporated into and made a part of this Agreement as fully as though set forth in their entirety in this Paragraph 1.
- 2. Klaucens, Salvation Army and Association hereby consent to Klaucens and his successors in interest to Unit 511, exclusive use of parking space P-53
- 3. Klaucens, Salvation Army and Association hereby consent to Salvation Army and its successors in interest to Unit 415, exclusive use of parking space P-61.
- 4. The consent hereby created shall by perpetual and constructed as a covenant running with the land, subject to the conditions, reservations and covenants contained in the Declaration of Condominium Ownership and Easements, Restrictions, Covenants and By-Laws for Wolfram Towers Homeowners Condominium Association as amended from time to time.
