

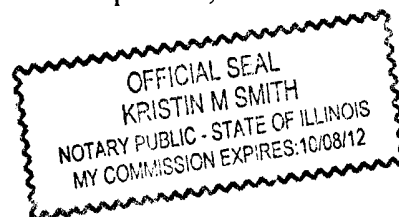

This Order shall not be the basis for a suit upon the Note.

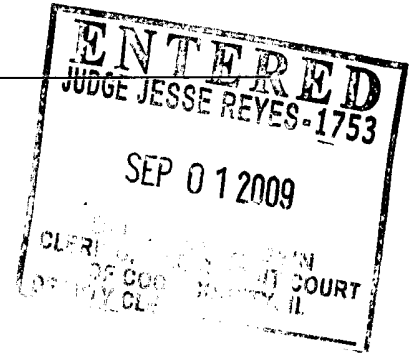

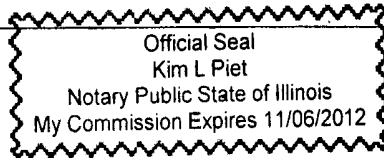
