IT IS HEREBY ORDERED THAT:

1. Defendant(s) Indy Mac and his / her / their / its agents, heirs, legatees, successors, and assigns shall be permanently enjoined and restrained from renting, using, leasing, or occupying the: subject premises until the same have established full compliance with the Municipal Code of the City of Chicago as stated in this cause and further order of court. Defendant(s) and his / her / their / its agents, heirs, legatees, successors, and assigns shall maintain the subject property in a sanitary, boarded, and secure condition while it remains subject to this injunction.
2. The court reserves jurisdiction of this matter for the purposes of modification, enforcement, or termination of this permanent injunction.
3. This order is final, appealable, and enforceable, the court finding no just cause or reason to delay its enforcement or appeal.
4. The prior judgment of \$9,500 plus \$100 in court costs entered 12-02-09 against LaShawn Shorter shall stand as final.
5. Defendant IndyMac shall block access to the porch within 21 ~~30~~ days
