THIS AGREEMENT, made this 3rd day of August, 2009, By and between FIRST COMMUNITY BANK AND TRUST BY DONNA BARBER, VICE PRESIDENT – MORTGAGE LOANS, the Owner of the mortgage or trust deed hereinafter described, and Althea Machtemes, a single person*, representing herself or themselves to be the owner or owners of the real estate hereinafter and in said deed described ("Owner"), WITNESSECH:

The parties hereby agree to extend the time of payment of the indebtedness evidenced by the principal promissory note or notes of Althea Machtemes dated December 3, 2008, secured by a mortgage or trust deed in the nature of a mortgage registered/recorded December 15, 2008, in the office of the Registrar of Titles/Recorder of Cook County, Illinois, as Document No. 0835045051 conveying to FIRST COMMUNITY BANK AND TRUST contain real estate in Cook County, Illinois, described as follows:

1. The amount remaining unpaid on the indebtedness is \$18,937.19 Said remaining indebtedness of \$18,937.19 shall be paid on or before August 3, 2013

Said principal sum and interest at the rate of 8.50% per annum, on the balance of principal remaining from time to time unpaid, shall be payable in installments as follows: Four and led sixty-seven and 88/100 (\$467.88) Dollars on the 3rd day of September, 2009, and Four hundred sixty-seven dollars and 88/100 (\$467.88) Dollars, or more, on the 3rd day of each successive month thereafter, to and including the 3rd day of July, 2013, with a final payment of the balance due on August 3, 2013. All such payments on account of the indebtedness shall be first applied to the interest on the balance of principal unpaid, to the date of payment, and the remainder to principal.

Payments are to be made at the First Community Bank and Trust, Beecher, Illinois, or at such other place as the legal holder of the note may from time to time in writing appoint, and the Owner in consideration of such extension promises and agrees to pay the principal sum secured by said mortgage or trust deed as and when therein provided, as hereby extended, and to pay interest thereon until **August 3, 2013**, at the rate of -8.50- per cent per annum, and thereafter until maturity of said principal sum as hereby extended, at the rate of -8.50- per cent per annum, and interest after maturity at the rate of -13.50- per cent per annum, and to pay both principal and interest in the coin or currency provided for in the mortgage or trust

deed hereinabove described, but if that cannot be done legally then in the most valuable legal tender of the United States of America current on the due date thereof, or the equivalent in value of such legal tender in other United States currency, at such banking house or trust company as the holder or holders of the said principal note or notes may from time to time in writing appoint, and in default of such appointment then at 1111 Dixie Hwy., P.O. Box 457, Beecher, IL 60401.

- 2. If any part of said indebtedness or interest thereon be not paid at the maturity thereof as herein provided, or if default in the performance of any other covenant of the Owner shall continue for twenty days after written notice thereof, the entire principal sum secured by said mortgage or trust deed, together with the then accrued interest thereon, shall, without notice, at the option of the holder or holders of said principal note or notes, become and be due and payable, in the same manner as if said extension had not been granted
- 3. This agreement is supplementary to said mortgage or trust deed. All the provisions thereof and of the principal note or notes, including the right to declare principal and accrued interest due for any cause specified in said nor gage or trust deed or notes, but not including any prepayment privileges unless herein expressly provided for, shall remain in full force and effect except as herein expressly modified. The Owner agrees to perform all the covenants of the grantor or grantors in said mortgage or trust deed. The provisions of this agreement shall insure to the benefit of any holder of said principal note or notes and interest notes and shall bing the heirs, personal representatives and assigns of the Owner. The Owner hereby waives and releases all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois with respect to said real estate. If the Owner consists of two or more persons, their liability hereunder shall be joint and several.

In the event the property described herein is so d by the maker hereof, then note described herein shall be due and payable in full instanter.

In the event and in each case of failure of the undersigned to make any payment of whatever nature, periodic or otherwise, in this Note or in the Mortgage or Trust Deed securing it provided, and if such failure continues for fifteen (15) days, the Bank may, at its option, impose a penalty, which shall be designated a "late charge", which the undersigned agrees and promises to pay monthly, as long as such delinquency is not rectified, in addition to all other payments herein or in said Mortgage or Trust Deed provided. Such late charge shall be equal to -5.00- percent (5%) of the everdue payment of principal and interest.
