- 3. The interest of each and every beneficiary under said Trust Agreement and hereunder, and of all person laiming under any of the beneficiaries, shall be only in the earnings, avails and proceeds arising from the sale or other disposition of the trust property and such interest is hereby declared to be personal property only, and the beneficiary or beneficiaries of the trust shall not have any title or interest therein, legal or equitable, except as stated.
- 4. In the event of the inability, refusal of the Co-Trustees herein named, to act, or upon their removal from the County, either CAROLYN MILLS or ANGELINE O'BRIEN is then appointed as Successor Trustee herein vith like powers and authority as is vested in the Trustee named herein.

All of the covenants, conditions, powers, righ's and duties vested hereby, in the respective parties, shall inure to and be binding upon their hei s legal representatives and assigns.

If the title to any of the above real estate now is or hereafter shall be registered, the Registrar of Titles is directed not to register or note the Certificate of Title, duplicate thereof, or memorial, the words, "in trust" or "upon condition", or "with limitation" or words of similar import, in compliance with the statute of the State of Illinois in such case made and provided.

The Grantors hereby waive and release any and all right and benefit under and by virtue of the Statutes of the State of Illinois providing for the exemption of homestead from sale or execution or otherwise.
