#### RECORDER'S STAMP

WHEREAS NICOLAS RIVERA represents and acknowledges that he is the owner and holder of a note and mortgage dated October 24, 2006 made by JUAN CHAVEZ and ARACELI CHAVEZ and given to NICOLAS RIVERA to secure an indebtedness in the amount of \$50,000.00, said mortgage having been recorded in the Recorder's Office of Cook County, Illinois on December 11, 2006 as Document Number 0634520018.

WHEREAS, in order to avoid a possible default under the terms of the note and mortgage and to avoid a possible foreclosure or other collection proceeding with respect to the Mortgage and Assignment of Rents recorded in the Recorder's office of Cook County Illinois as Document Number 0634520016 and Document Number 0634520017, JUAN CHAVEZ and ARACELI CHAVEZ have requested that MUTUAL FEDERAL SAVINGS AND LOAN ASSOCIATION OF CHICAGO agree to a modification of the loan represented by the Note and related loan documents secured by the above mentioned Mortgage and Assignment of Rents recorded in the Recorder's office of Cook County Illinois as Document Number 0634520016 and Document Number 0634520017.
