This Deed is subject to all rights, easements, covenants, restrictions and reservations contained in the Condominium Declaration the same as though the provisions of said Condominium Declaration were recited and stipulated at length herein.

And the Grantor, for itself and its successors, does covenant, promise and agree, to and with the Grantee, that it has not done or suffered to be done, anything whereby the said premises hereby granted are, or may be, in any manner encumbered or charged, except as herein recited; and that the said premises, against all persons lawfully claiming, or to claim the same, by, through or under it, Grantor WILL WARRANT AND DEFEND, subject to (1) current nondelinquent real estate taxes and taxes for subsequent years; (2) other assessments or installments thereof not due and payable as of the date hereof; (3) the Condominium Act of the State of Illinois; (4) the Condominium Declaration and the Parking REA (as defined in the Condominium Declaration); (5) public, private and utility easements, (6) covenants, conditions and restrictions of record that do not adversely affect Grantee's use of the premises for residential purposes; (7) applicable zoning, planned unit development and building laws, ordinances and restrictions; (8) leases and licenses affecting the common elements of the Condominium; (9) other matters over which the title insurer is willing to insure; (10) acts done or suffered by the Grantee; (11) Grantee's mortgage if any; (12) the lease, if any, to which Grantee is to take subject pursuant to Paragraph 9 of that certain Condominium Purchase Agreement by and between Grantor and Grantee; and (13) rights of the public, the City of Chicago and State of Illinois in and to that part of the land taken and used for waterways, roads and highways, if any; and (14) provided that none of the above shall reasonably interfere with Purchaser's use of the Purchased Unit as a single family condominium.
