Agreed Order of Settlement

This case is before the Court to approve the terms of this Agreed Order of Settlement with Permanent Injunction between Plaintiff City of Chicago ("City") and Defendants Founder's Bank, as Trustee U/T/A Dated January 15, 2003, Trust Number 6210, Mount Greenwood Local Redevelopment Corporation, and Family Dollar, Incorporated (collectively "Defendants").

The parties wish to resolve this case without a trial, and have read and voluntarily agreed to the terms of this Order. The Court makes the following findings of fact and law, and orders Defendants to comply with each of the terms stated in this Order:

1. The Court has *in personam* jurisdiction over the parties and *in rem* jurisdiction over the property commonly known as 11041 South Kedzie Avenue, Chicago, Illinois ("subject property"), and legally described as:

Lots 57 to 63, Both Inclusive, in Block 4 in J.S. Hovlands Resubdivision of Blocks 1, 2, and 3 (Except Lots 14, 15, 17, and 18) and all of Block 4 of J.S. Hovlands Subdivision of the Southwest 1/4 of the Southwest 1/4 of Section 13, Township 37 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois.

Permanent index numbers: 24-13-308-036-0000, -037-0000, -038-0000, -039-0000,

-040-0000, -041-0000, and -042-0000.

- 2. The subject property contains a commercial building that contains a Family Dollar store, with an open, peved area used to park motor vehicles to the north of the building ("off-street parking area"). The subject property is located in a B3-1 Community Shopping District.
- 3. Defendant Founder's Bank was the trustee of land trust number 6210 that owns legal title to the subject property under trustee's deed dated March 15, 2004.
- 4. Defendant Mount Greenwood I ocal Redevelopment Corporation was the legal beneficiary of land trust number 6210, that owns legal title to the subject property.
- 5. The City alleges in its Complaint for Equitable and Other Relief that beginning on or about June 10, 2008, and continuing to the present, Defendants used the subject property to park motor vehicles outdoors, in violation of the Coicego Zoning Ordinance.
- 6. Defendants agree to plead liable to all Counts of the City's Complaint and agree to pay the City a fine of \$500.00. Defendants further agrees to reimburse the City for its litigation costs in the amount of \$228.00. Payment of the \$728.00 shall be made by certified check or money order payable to the "City of Chicago" and delivered to Kiraberly White at 30 North LaSalle Street, Suite 700, Chicago, Illinois, 60602, no later than November 6, 2009.
- 7. Defendants agree to maintain the property in accordance with the approved plans.
- 8. The Court shall retain jurisdiction of this Agreed Order solely for the purpose of enforcement of the terms of this Agreed Order.
