

- E. "BORROWER'S RIGHT TO REINSTATE" DELETED. Section 19 is deleted.

Borrower represents and warrants that Borrower has not executed any prior assignment of the Rents and has not performed, and will not perform, any act that would precent Lender from exercising its rights under this paragraph.
